Objectives and investment policy

The Fund is actively managed and as such may invest in securities that are not included in the index which is MSCI World Health Care 10/40 (NR). The Benchmark is used for performance comparison only. The Fund is not benchmark constrained and its performance may deviate significantly from that of the benchmark.

The Fund seeks to increase the value of its assets over the medium term by investing in shares issued worldwide by companies which innovate or benefit from healthcare innovation including but not limited to advances in genetic sequencing, drug delivery, miniaturization, bio-compatible materials, haptics and information technology in the healthcare field.

The investment team applies also BNP PARIBAS ASSET MANAGEMENT's sustainable Investment Policy, which takes into account Environmental, Social and Governance (ESG) criteria such as but not limited to reduction of emissions of greenhouse gas, respect of human rights, respect of minority shareholders rights, at each step of the investment process of the Fund.

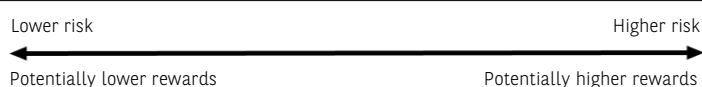
An extra-financial strategy may comprise methodological limitations such as the ESG Investment Risk as defined by the asset manager.

Incomes are systematically reinvested.

The risk category is justified by the investment mainly in Stocks and Shares, the value of which can fluctuate considerably. These fluctuations are often amplified in the short term.

The Exit Charge shown reflects a contingent deferred sales charge (CDSC fee) of up to 2.25% that will be levied in case of redemptions of the share before the third anniversary of its issue. Over the 3 years starting from the issue, the maximum CDSC fee rate applicable to the redemptions will decrease respectively each year by 0.75% until the end of the third year.

(*) The **ongoing charges** figure is based on past expenses determined as of 31 October 2021.

This figure may vary from year to year. It excludes:

- Portfolio transaction costs, except in the case of an entry/exit charge paid by the Fund when buying or selling units in another collective investment undertaking. In case of conversion, the investors may be charged a maximum fee of 1.5%.
