# **Key Investor Information**

This Fund is managed by BNP PARIBAS ASSET MANAGEMENT Luxembourg, part of the BNP Paribas Group.

## Objectives and investment policy

The Fund seeks to increase the value of its assets over the medium term by investing in shares issued by socially responsible US companies, or socially responsible companies operating in the USA.

It is actively managed and as such may invest in securities that are not included in the index which is S&P 500 (USD) NR.

The portfolio is built based on a systematic approach, combining several equity factor criterions such as value, profitability, low-volatility and momentum. The investment team applies also BNP PARIBAS ASSET MANAGEMENT's sustainable Investment Policy, which takes into account Environmental, Social and Governance (ESG) criteria such as but not limited to reduction of emissions of greenhouse gas, respect of human rights, respect of minority shareholders rights, at each step of the investment process of the Fund.

The Fund follows the Enhanced ESG approach which means that the Fund implements more explicit ESG tilts (Invest in the most sustainable companies according to specific criteria and/or incorporating a wider range of exclusions) leading to more stringent ESG and/or Carbon performance targets.

The quantitative approach is implemented in order to consistently achieve the following targets:


- a portfolio's ESG score higher than the ESG score of the index after eliminating at least 20% of the least well-rated securities, and

- a portfolio's carbon footprint at least 50% lower than the carbon footprint of the index.

An extra-financial strategy may comprise methodological limitations such as the ESG Investment Risk as defined by the asset manager. Incomes are systematically reinvested.

Investors are able to redeem on a daily basis (on Luxembourg bank business days) as described in the prospectus

## Risk and reward profile

Other risks materially relevant to the Fund which are not adequately captured by the indicator are described below:

- Liquidity Risk: This risk arises from the difficulty of selling an asset at a fair market price and at a desired time due to lack of buyers.
- Operational and Custody Risk: Some markets are less regulated than most of the international markets; hence, the services related to custody and liquidation for the subfund on such markets could be more risky.

#### Charges

The Exit Charge shown reflects a contingent deferred sales charge (CDSC fee) of up to 2.25% that will be levied in case of redemptions of the share before the third anniversary of its issue. Over the 3 years starting from the issue, the maximum CDSC fee rate applicable to the redemptions will decrease respectively each year by 0.75% until the end of the third year.

(\*) The  $\mathbf{ongoing}\ \mathbf{charges}\ \mathbf{f}$  igure is based on past expenses determined as of 31 October 2021.

This figure may vary from year to year. It excludes:

• Portfolio transaction costs, except in the case of an entry/exit charge paid by the Fund when buying or selling units in another collective investment undertaking. In case of conversion, the investors may be charged a maximum fee of 1.5%.
