#### Objectives and Investment Policy

The Fund seeks to increase the value of its assets over the medium term by investing in shares issued by Asian companies, and/or companies operating in Asia (excluding Japan), with a solid financial structure and/or potential for earnings growth.


It may be invested in Mainland China shares restricted to foreign investors such as China A shares which can be listed on a Stock Connect or through a use of a specific license granted by the Chinese authorities.

It is actively managed and as such may invest in securities that are not included in the index which is MSCI AC Asia ex-Japan (NR).

Income are systematically reinvested.

Investors are able to redeem on a daily basis (on Luxembourg bank business days).

#### Risk and Reward Profile

Other risks materially relevant to the Fund which are not adequately captured by the indicator are described below:

- <u>Liquidity Risk:</u> This risk arises from the difficulty of selling an asset at a fair market price and at a desired time due to lack of buyers.
- <u>Operational and Custody Risk:</u> Some markets are less regulated than most of the international markets; hence, the services related to custody and liquidation for the subfund on such markets could be more risky.


