Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

Product

Capital Group Emerging Markets Total Opportunities (LUX) (the "fund"), a sub-fund of Capital International Fund SICAV, Class Zgd EUR (LU0815118459)

What is this product?

Type

This fund is an open-ended Luxembourg SICAV (Société d'Investissement à Capital Variable).

This fund is a sub-fund of Capital International Fund, an umbrella structure comprising different sub-funds. This document is specific to the fund and share class stated at the beginning of this document. The prospectus, annual and semi-annual reports are prepared for the umbrella.

The assets and liabilities of each fund are segregated by law, which means that no individual fund will be liable with its assets for liabilities of another fund within the umbrella fund.

Investors may switch their shares in the fund for shares in the same or another sub-fund within the umbrella, subject to meeting certain requirements as set out in the prospectus.

Investment objective

Long-term growth and preservation of capital with lower volatility of returns than emerging markets equities by investing primarily in Investment Grade and High Yield Bonds (both corporates and sovereigns), equity, hybrid securities and short-term instruments normally listed or traded on other regulated markets of issuers in eligible investment countries. Securities of Emerging Markets issuers are defined as those: (1) from issuers in emerging markets; (2) primarily traded in emerging markets; (3) that are denominated in emerging markets currencies; or (4) that are from issuers deemed to be suitable for the fund because they have or are expected to have significant economic exposure to emerging markets (through assets, revenues, or profits). Unlisted securities may also be purchased.

The fund may invest up to 10% of its assets in securities of issuers which are not emerging markets issuers. for the avoidance of doubt and notwithstanding the above 10% limit, the fund may invest in such

issuers' sovereign debt instruments rated AAA by Standard & Poor's or Fitch or Aaa by Moody's in lieu of cash, without being considered as securities of issuers from countries other than eligible investment countries.

The fund may invest up to 10% in distressed securities.

Intended retail investor

The fund is actively managed and particularly suitable for investors who are seeking equity-like returns, with a volatility lower than that of a traditional emerging market equity fund. As investments carry a risk of loss, an investor should have a basic knowledge of financial instruments to understand related risks, which are defined in the fund's 'What are the risks and what could I get in return?' section. The fund is appropriate for investors with a medium to long-term investment horizon and does not require prior experience with PRIIPs or similar investments.

The fund is actively managed and without any constraints to a benchmark index. Any information in relation to an index is provided for the purposes of risk management, context and illustration, as applicable.

You can choose to redeem your investment at any time prior to the recommended holding period. Details of the procedure for doing so can be found in the fund's prospectus.


The fund has no maturity date. The PRIIP manufacturer is not entitled to terminate the PRIIP unilaterally. Investors in the fund may buy and sell shares on any dealing day (as defined in the Prospectus). If you invest in a distributing share class, income from investments will be paid out to you. If you invest in an accumulating share class, income will be reinvested.

What are the risks and what could I get in return?

Risk indicator



The risk indicator assumes you keep the product for 5 years.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class.

This figure rates the likelihood of losing money in the future, based on the Net Asset Value of this Share Class over the last ten years as a medium-low risk.

Be aware of currency risk. If you select a foreign currency share class, you will be exposed to currency risk, receive payments in a different currency to your local currency and your final return will depend on the exchange rate between these two currencies. This risk is not considered in the indicator shown above.

Investments in the fund are subject to general investment risks, such as market, counterparty and liquidity risks. Any specific risks to this fund are detailed in the prospectus.

This product does not include any protection from future market performance so you could lose some or all of your investment.

Performance Scenarios

The stress scenario shows what you might get back in extreme market circumstances.

What happens if Capital International Management Company Sàrl is unable to pay out?

For your protection, the fund's assets are held in safekeeping by its depositary, J.P. Morgan SE, Luxembourg Branch (the 'Depositary'). In the event of the Depositary's insolvency, the fund may suffer a financial loss. However, this risk is mitigated to some extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the fund. If the fund is terminated or wound up, the assets will be liquidated and you shall receive a share of any proceeds, but you may lose part or all of your investment. Your investment is not covered by the Luxembourg compensation scheme.

What are the costs?

Costs over time

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and they will affect your investment.

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest and how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.
- EUR 10 000.00 is invested.

How long should I hold it and can I take money out early?
