What is this product?

This product is an investment fund.

Objectives

Investment objective The subfund's main objective is to invest in space economy stocks (aerospace sector).

Investment policies Stock investments must represent at least two-thirds of net assets.

Companies are selected for long-term investment based on fundamental analysis.

The portfolio is invested globally, without any geographic restrictions, in securities from developed countries, OECD member countries and emerging countries, which are part of the EMBI Global Diversified Index. Such investments could represent a maximum of 20% of the investment portfolio.

The subfund may invest a maximum of 10% of its assets in UCI or UCITS units or shares.

The subfund may also hold, on an ancillary basis, liquid assets (cash, term deposits – in accordance with Section V, Investment Restrictions, point (3)), and use derivative financial instruments (only ETDs listed on market indices, in particular EURO STOXX 50® Index Futures (FESX); Nasdaq Futures; S&P 500 Futures, and options on specific securities: (i) the purchase of call and put options and (ii) the sale of call options only in the form of covered call options, and the sale of put options), both for risk hedging and for the purpose of managerial efficiency.

Redemption and Dealing Shares of the Fund may be redeemed on demand, with dealing normally on a daily basis.

Distribution Policy This Share Class does not pay dividends. Earned income is retained in the NAV.

Intended retail investor

This product is intended for investors who plan to stay invested for at least 5 years and are prepared to take on a medium-high level of risk of loss to their original capital in order to get a higher potential return. It is designed to form part of a portfolio of investments.

What are the risks and what could I get in return?

Risks



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 5 out of 7, which is a medium-high risk class.

This rates the potential losses from future performance at a medium-high level, and poor market conditions will likely impact the capacity of ADEPA Asset Management S.A. to pay you.

Performance scenarios

What happens if CB-Accent Lux is unable to pay out?

If we are not able to pay you out what we owe you, you are not covered by any national compensation scheme. To protect you, the assets are held with a separate company, a depositary. Should we default, the depositary would liquidate the investments and distribute the proceeds to the investors. In the worst case, however, you could lose your entire investment.

What are the costs?

Costs over time

- in the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario,
- 10,000 USD is invested.
