What is this product?

This product is an investment fund.

Objectives

Investment objective The company CB–ACCENT LUX offers easy access to the different financial markets, while providing risk diversification.

Investment policies CB-ACCENT LUX - Erasmus Bond Fund invests at least two thirds of its net assets in fixed or variable rate bonds of first class issuers of an OECD Member State. Said transferable securities should be rated at least as Investment Grade. Up to 10% of assets may be invested through other collective investments.

However, up to 30% of net assets may be invested in instruments with a rating lower than Investment Grade and/or of issuers from non- OECD Member States.

On an ancillary basis, the Sub-fund may also hold liquidity and use derivative instruments for risk hedging or efficient portfolio management.

As with all vehicles that invest in transferable securities, the value of the Sub-fund may change. Therefore, net asset value per share may increase or decrease depending on market performance.

Redemption and Dealing Shares of the Fund may be redeemed on demand, with dealing normally on a daily basis.

Distribution Policy This Share Class does not pay dividends. Earned income is retained in the NAV.

Intended retail investor

This product is intended for investors who plan to stay invested for at least 3 years and are prepared to take on a low level of risk of loss to their original capital in order to get a higher potential return. It is designed to form part of a portfolio of investments.

What are the risks and what could I get in return?

Risks



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 2 out of 7, which is a low risk class.

This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact the capacity of ADEPA Asset Management S.A. to pay you.

Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

Performance scenarios

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

The unfavourable, moderate, and favourable scenarios shown are illustrations using the worst, average, and best performance of the product over the last 10 years. Markets could develop very differently in the future.

The stress scenario shows what you might get back in extreme market circumstances.

Unfavourable: this type of scenario occurred for an investment between September 2019 and September 2022.

Moderate: this type of scenario occurred for an investment between March 2014 and March 2017.

Favourable: this type of scenario occurred for an investment between January 2017 and January 2020.

What happens if CB-Accent Lux is unable to pay out?

If we are not able to pay you out what we owe you, you are not covered by any national compensation scheme. To protect you, the assets are held with a separate company, a depositary. Should we default, the depositary would liquidate the investments and distribute the proceeds to the investors. In the worst case, however, you could lose your entire investment.

What are the costs?

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- in the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario,
- 10,000 USD is invested.

How long should I hold it and can I take money out early?

Recommended holding period: 3 years
