What is this product?

Type: Shares of a Sub-Fund of CPR Invest, an Undertaking for Collective Investments in Transferable Securities (UCITS), established as a SICAV.

Term: The term of the Sub-Fund is unlimited. The Management Company may terminate the fund by liquidation or merger with another fund in accordance with legal requirements.

Objectives: The Compartment's objective CPR Invest – Global Equity All Regime World ESG (CPR Invest – GEAR World ESG) is to outperform over a long-term period (minimum of five years) the MSCI World All Countries Net Return Index (denominated in euro), while integrating ESG criteria into the Compartment's stock selection and analysis process.

The investment process consists in defining stock selection strategy (single/multi factors strategies) according to market regimes.

The initial investment universe is wider compared to composition of its benchmark as it integrates the overall equity market. Then, the securities that are likely to be included in the portfolio are identified after applying different kinds of filters, for example market capitalization and liquidity filters.

The Management Company integrates an additional sustainable approach by analysing companies that have already been selected on the basis of its internal ESG analysis methodology and excluding those based on the following :

- worst overall ESG scores ;
- worst scores for specific E, S and G criteria considered the most relevant depending on their business sector.

At least 90% of portfolio stocks have an ESG score. The Management Company undertakes to exclude at least 20% of stocks from the investment universe by applying its ESG approach. In order to reconcile the search for performance with the development of socially responsible practices, ESG criteria are considered based on a combination of normative, best-in-class and commitment approaches.

The best-in-class approach does not exclude any sector of activity in principle. All economic sectors are therefore represented in this approach and the Compartment may therefore be exposed to some controversial sectors.

In order to limit the potential non-financial risks for these sectors, the Compartment applies the exclusions set out above.

The Compartment equity exposure will be between 75% and 120% of its

assets.

The maximum Compartment currency risk exposure on all currencies will be 120% of its assets.

The Compartment is invested for at least 75% of its assets in equity and equity equivalent securities of any countries without constraints of sector and capitalization. Among this proportion of 75% of its assets, the Compartment may invest in China A shares via Stock Connect within a maximum of 25% of its assets.

Derivatives instruments may be used by the Compartment for hedging, exposure purposes and/or efficient portfolio management.

The Compartment is actively managed and seeks to outperform the Benchmark. The Compartment is mostly exposed to the issuers of the Benchmark, however, the management of the Compartment is discretionary, and will invest in issuers not included in the Benchmark. The Compartment monitors risk exposure in relation to the Benchmark however the extent of deviation from the Benchmark is expected to be material.

The Compartment is a financial product that promotes ESG characteristics pursuant to Article 8 of the Disclosure Regulation.

Intended Retail Investor: This product is intended for investors, with a basic knowledge of and no or limited experience of investing in funds seeking to increase the value of their investment over the recommended holding period and who are prepared to take on a high level of risk to their original capital.

Redemption and Dealing: Shares may be sold (redeemed) as stated in the prospectus at the respective dealing price (net asset value). Further details are provided in the CPR Invest prospectus.

Distribution Policy: As this is a non-distributing share class, investment income is reinvested.

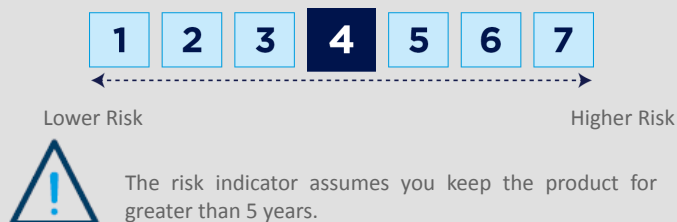

We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact our capacity to pay you.

What happens if CPR Asset Management is unable to pay out?

A separate pool of assets is invested and maintained for each Sub-Fund of CPR Invest. The assets and liabilities of the Sub-Fund are segregated from those of other sub-funds as well as from those of the Management Company, and there is no cross-liability among any of them. The Sub-Fund would not be liable if the Management Company or any delegated service provider were to fail or default.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, and how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

How long should I hold it and can I take money out early?
