## What is this product?

### TYPE OF PRODUCT

The product is a sub-fund of CROSSFUND SICAV, an Undertaking for Collective Investment in Transferable Securities (UCITS) incorporated as a variable capital investment company (SICAV) under the laws of Luxembourg.

### TERM

The Sub-Fund is established for an unlimited duration. However, the Directors may decide to close this product under certain circumstances.

### OBJECTIVES

#### Objectives and investment policy

The investment objective of the Sub-Fund is to achieve long term capital appreciation by pursuing Pan-European focus exposure opportunities in small and mid-cap companies involved in diverse industry fields.

The Sub-Fund will mainly invest in equities and equity related securities (including but not limited to depositary receipts, REIT (Real Estate Investment Trust)) of small and mid-capitalisation companies which are domiciled, headquartered or exercise the predominant part of their economic activity in Europe. European small and mid-capitalisation companies are those that generally have (at the time of purchase) a market capitalisation below EUR 10 billion, or the equivalent in local currencies.

Except the European geographical and market capitalisation constraints, the Sub-Fund can be exposed to other countries (including emerging markets), any economic sector, any currency in which investments will be denominated. However, depending on financial market conditions, a particular focus can be placed in a single country (or some countries), and/or in a single economic sector, and/or in a single currency.

On an ancillary basis, the Sub-Fund may invest in any other type of eligible assets, such as equities other than those above-mentioned, debt securities, money market instruments, undertakings for collective investment (UCIs), cash.

If the investment manager considers this to be in the best interest of the shareholders, on a temporary basis and for defensive purposes, the Sub-Fund may also, hold, up to 100% of its net assets in liquidities, as among others cash deposits, money market UCIs and money market instruments.

**Derivatives** For hedging and for investment purposes, the Sub-Fund may use any type of financial derivative instruments. However, in normal market conditions, the investment manager intends to use futures and options offering an exposure to equities, contracts for difference, currency derivatives.

**Benchmark** The Sub-Fund is actively managed. The Sub-Fund has no benchmark index and is not managed in reference to a benchmark index.

**Dividend Policy** This Class is cumulative. Dividend distributions are not planned.

**Share Class Currency** The currency of the Class is CHF.

The recommended holding period of this product is determined to allow sufficient time for this product to reach its objectives and avoiding short term market fluctuations.

The return of the product is determined using the Net Asset Value (the "NAV") calculated by FundPartner Solutions (Europe) S.A. (the "Administrative Agent"). This return depends mainly on the market value fluctuations of the underlying investments.

### INTENDED RETAIL INVESTORS

The product is suitable for retail investors with limited knowledge of the underlying financial instruments and no financial industry experience. The product is compatible with investors who may bear capital losses and who do not need capital guarantee. The product is compatible with clients looking for growing their capital and who wish to hold their investment over 5 years.

### OTHER INFORMATION

**Depositary** Bank Pictet & Cie (Europe) AG, succursale de Luxembourg (the "Depositary").

**Asset segregation** The assets and liabilities of each sub-fund are segregated by law, which means that the performance of the assets in other sub-funds does not influence the performance of your investment.

**Dealing** The NAV for the Class is calculated on each bank business day in Luxembourg based on the pricing of the preceding business day (the "Valuation Day"). The cut-off time to submit subscriptions and/or redemption orders is 3 p.m. at the latest on the Valuation Day.

**Switching** Shareholders may apply for any shares of any sub-funds to be converted into shares of another sub-fund, provided that the conditions for accessing the target class, type or sub-type are fulfilled with respect to the Sub-Fund, on the basis of their respective NAV calculated on the Valuation Day following receipt of the conversion request. The redemption and subscription costs connected with the conversion may be charged to the shareholder as indicated in the prospectus. ## What happens if FundPartner Solutions (Europe) S.A. is unable to pay out?

The Management Company is not making any payment to you in relation to the Sub-Fund and you would still be paid in case of a default from the Management Company.

The Sub-Fund's assets are held with a separate company, the Depositary, so the Sub-Fund's ability to pay out would not be affected by the insolvency of the Management Company. However, in the event of the Depositary's insolvency, or its delegates, the Sub-Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Sub-Fund. The Depositary will also be liable to the Sub-Fund or its investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfill its obligations (subject to certain limitations).

If the Sub-Fund is terminated or wound up, the assets will be liquidated and you will receive an appropriate share of any proceeds but you may lose part or all of your investment.

There is no compensation or guarantee scheme protecting you from a default of the Depositary.

## What are the costs?

### Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does.
