What is this product?

The product is a UCITS - Special property in accordance with German authorization.

Term

This product is an open-ended fund without predefined maturity. For information on redemption possibilities please refer to section "How long should I hold it and can I take out my money early?". The Company may, however, terminate its right to manage the fund by giving a minimum of six months' notice by way of an announcement in the Bundesanzeiger and additionally in the annual report or semiannual report. DEGEF-Bayer-Mitarbeiter-Fonds was launched in 1973.

Objectives

The fund is actively managed. The fund is managed in reference to a benchmark. The objective of the investment policy is to achieve an appreciation above the benchmark, which comprises 50% DJ STOXX 50 and 50% JPM EMU, in combination with a steady return. To achieve this, the fund invests in bonds, as well as other instruments. The fund may invest more than 35% of the managed assets in bonds of various public issuers. Bonds held for the account of the fund must originate from at least six issues; no more than 30% of the fund's assets may be held in one issue. At least 25% of the fund's assets are invested in equities. In addition, bank balances, money market instruments and investment fund units, as well as all assets mentioned in the Terms and Conditions of Investment and the Investment Act, may be acquired. The selection of the individual investments is at the discretion of the fund management. The return of the product is reflected by the daily calculated net asset value per unit and the distribution amount if applicable. The majority of the fund's securities or their issuers are expected to be components of the benchmark. The fund management will use its discretion to invest in e.g. securities, sectors, ratings that are not included in the benchmark in order to take advantage of specific investment opportunities. The strategy provides investors with access to the market for global issuers. The fund's positioning may deviate substantially from the benchmark (e.g., due to a positioning outside of the benchmark or considerable underweighting or overweighting). Due to the fund strategy characteristics already mentioned, the portfolio's deviation from the benchmark is generally relatively high. Despite the fact that the fund aims to outperform the benchmark, the potential outperformance might be limited depending on the prevailing market environment (e.g. less volatile market environment) and actual positioning versus the benchmark. Returns and gains are not distributed but are reinvested in the fund. The depositary is State Street Bank International GmbH, Germany. The summary risk indicator is a guide to the level of risk of this product compared to other products. What happens if DWS Investment GmbH is unable to pay out?

The assets of the fund are kept separately from the own assets of the management company DWS Investment GmbH. Investors of the fund cannot suffer any financial loss as a result of this separation due to a failure of the management company. In the event of a default by the depositary State Street Bank International GmbH, Germany, investors of the fund may suffer a financial loss if their deposits are not covered by the Deposit Guarantee Fund of the Bundesverband deutscher Banken e.V.. If deposits on the fund are made with other credit institutions, investors may also suffer a financial loss, provided that such deposits are not covered by any existing deposit guarantee schemes. The protection of deposits of the fund may also be limited in the case of existing deposit guarantee schemes, as they regularly have restrictions on the coverage of deposits in accordance with their statutes.
