This document provides you with key investor information about this fund. It is not marketing material. The DJE - Concept is a sub-fund of the DJE.

The Fund is managed by DJE Investment S.A. ("management company").

### Objectives and investment policy

The investment objective of the DJE – Concept (sub-fund) is to achieve an appropriate appreciation in the sub-Fund currency, taking into account the investment risk. The purpose is to generate capital appreciation over the long term.

The sub-fund is a mixed fund. With regard to the principle of risk spreading the sub-fund's assets are invested in shares or bonds of all kinds that are listed on the stock exchange or traded on another regular market which operates regularly, is recognized and open to the public, including zero coupon bonds and floating rate securities, certificates as well as convertible and option bonds whose warrants are denominated in securities. At least 25% of the sub-fund's assets are invested in shares. The composition of the portfolio will be performed actively and independently of any constraints regarding benchmarks, sectors, countries, duration, rating and market capitalization under consideration of ESG factors. The sub-fund may use financial instruments whose value depends on future prices of other assets (derivatives) for hedging and capital appreciation purposes. The relative VaR approach with a reference portfolio is used for risk measurement. The composition of the portfolio is not restricted by the reference portfolio and can therefore differ significantly from it.

Detailed information on the aforementioned (and/or further) opportunities to invest in the Fund can be found in the current sales prospectus.

In principle, investors may redeem their units on any banking day in Luxembourg, with the exception of 24 and 31 December. The redemption of units may be suspended in extraordinary circumstances if this is deemed necessary in the interests of investors.

The Fund reinvests but does not pay rewards to investors.

The unit class is classified in category 4 because its unit price typically fluctuated moderately and therefore both loss risks and profit opportunities can be correspondingly moderate.

Because of the calculation model used, all risks may not be taken into consideration when placing the Fund in a risk class.

Detailed information can be found in the section entitled "Risks" of the prospectus. The following risks have no direct influence on this categorisation, but may be significant for the Fund:

#### Credit risks

The Fund may invest part of its assets in bonds. The issuers of these bonds could become insolvent, causing the bonds to lose some or all of their value.

#### Liquidity risks

The Fund may invest part of its assets in securities that are not traded on a stock exchange or similar market. It may be difficult to find a buyer for such securities in the short term. As a result, the risk that share redemptions will be suspended may increase.

#### Counterparty risks

The Fund may enter into various transactions with counterparties. If a counterparty becomes insolvent, that party will not be able to meet some or all of its open obligations to the Fund.

#### Risks relating to the use of derivatives

The Fund may enter into derivative transactions for the purposes listed above in the section "Investment policy". This means increased opportunities, but also increased risk of losses. The use of derivatives to hedge against losses may also reduce the profit opportunities of the Fund.

#### Operating risks and custodial risks

The Fund may become a victim of fraud or other criminal acts. The Fund may also suffer losses due to misunderstandings or errors by employees of the Management Company, a depositary or external third parties. Finally, his management or the safekeeping of his assets may be adversely affected by external events such as fires, natural disasters or the like. The safekeeping of assets, in particular abroad, may entail a risk of loss resulting from insolvency, breaches of duty of care or improper conduct on the part of the custodian or a sub-custodian.

The charges you pay are used to pay the costs of running the sub-fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.

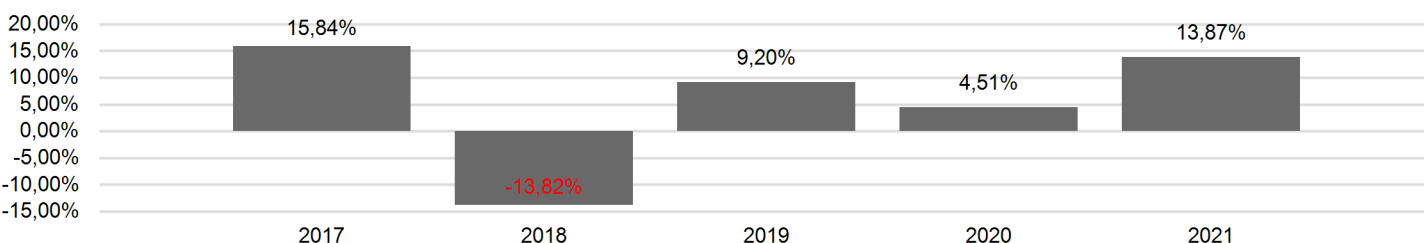
**Performance fee**

The unit class inherits the historical performance of the transferring unit class I of the "DJE Concept". The historical performance has been taken over by the DJE Investment S.A. and relates to the period since first issue of unit class I of the "DJE Concept" in 2001 till 30 September 2019. The "DJE - Concept" has essentially the same investment strategy.

Past Performance
