What is this product?

The product is a UCITS - Special property in accordance with German authorization.

Term

This product is an open-ended fund without predefined maturity. You may request the redemption of shares generally on each valuation date. The company may, however, suspend the redemption if extraordinary circumstances appear to make this necessary, taking into account the interests of the investors. Further, the company may restrict the redemption. The Company may, however, terminate its right to manage the fund by giving a minimum of six months' notice by way of an announcement in the Bundesanzeiger and additionally in the annual report or semiannual report. DWS TRC Top Asien was launched in 2011.

Objectives

The fund is actively managed. The fund is not managed in reference to a benchmark. The fund promotes environmental and social characteristics and is subject to the disclosure requirements of a financial product in accordance with article 8(1) of Regulation (EU) 2019/2088 on sustainability-related disclosures in the financial services sector. More ESG information is available in the sales prospectus and on the DWS website. The objective of the investment policy is to generate a return in euro. To achieve this, the fund invests at least 85% of its assets in shares of DWS ESG Top Asien (master fund). The objective of the investment policy of DWS ESG Top Asien is to achieve capital appreciation. To achieve this, the fund invests predominantly in high-quality equities of companies having their registered offices or principal business activity in Asia and that primarily generate their sales in this region. The following aspects shall be considered when selecting the equities: strong market position, sound financial ratios, better-than-average corporate management, strategic orientation of the company and shareholder-centered information policies. When selecting the suitable investments, environmental and social aspects as well as the principles of corporate governance ("ESG standards") are of key importance for the implementation of the fund's sustainable investment strategy. Issuers that generate their revenues from activities related to power generation or other use of nuclear energy and natural gas as well as from the extraction of uranium or natural gas may be acquired for the investment fund. In this context, the fund management is responsible for selecting the individual investments. Besides investing in the master fund, DWS TRC Top Asien may also invest in bank balances and derivatives for hedging purposes. Furthermore, a combination of suitable investment instruments are used to partially hedge the equity market risk for the master fund. Up to 80% of the equity market risk for the master fund can be hedged in this way. The equity market risk is determined at regular intervals. The hedge ratio is set using market risk indicators and market trend indicators that are determined daily and it is adjusted when defined thresholds are exceeded. By doing this, the aim is to participate as much as possible in the performance of the master fund when there is a positive market assessment, whereas, when there is a negative market assessment based on the results of the market risk indicators and market trend indicators, the aim is to limit the influence of market movements and accordingly hedge the equity market risk. The performance of the fund may therefore differ from that of the master fund. The return of the product is reflected by the daily calculated net asset value per unit and the distribution amount if applicable. The currency of the master fund is EUR. Returns and gains are not distributed but are reinvested in the fund. The depositary is State Street Bank International GmbH, Germany. What happens if DWS Investment GmbH is unable to pay out?

The assets of the fund are kept separately from the own assets of the management company DWS Investment GmbH. Investors of the fund cannot suffer any financial loss as a result of this separation due to a failure of the management company. In the event of a default by the depositary State Street Bank International GmbH, Germany, investors of the fund may suffer a financial loss if their deposits are not covered by the Deposit Guarantee Fund of the Bundesverband deutscher Banken e.V.. If deposits on the fund are made with other credit institutions, investors may also suffer a financial loss, provided that such deposits are not covered by any existing deposit guarantee schemes. The protection of deposits of the fund may also be limited in the case of existing deposit guarantee schemes, as they regularly have restrictions on the coverage of deposits in accordance with their statutes.

How long should I hold it and can I take money out early?

Recommended holding period: 7 years. The product has no minimum holding period.

It is expected that it will be possible to achieve the investment objective of the fund within this time frame. You may request the redemption of shares generally on each valuation date. No fees or penalties will be charged by the company for any such transaction.

There is no change on the risk return profile when you redeem your shares early.
