# What is this product?

**Type** This product is a share of an investment company qualifying as an undertaking for collective investment in transferable securities (UCITS).

Term

This sub-fund has no maturity date. However, the board of directors may decide to close the sub-fund under certain circumstances.

#### Objectives

To provide long-term capital growth through exposure to companies located in frontier markets throughout the world.

The sub-fund will invest at least 75% of its assets directly or indirectly in equity or equity-related securities (such as, but not limited to, ADRs and GDRs) of companies domiciled in frontiers markets or that exercise a significant part of their economic activity there. For the purpose of this sub-fund, frontier markets are defined as less advanced and less accessible emerging market countries that are included in Frontier Markets-related indices

The sub-fund may also invest in any country which is classified as an Emerging Market, or any other market not yet classified as Frontier Markets, but which, in the opinion of the Investment Manager, demonstrates economic characteristics of countries included in the Frontier Markets-related indices.

Benchmark: The portfolio is actively managed on a discretionary basis with reference to a benchmark. While the product compares its performance against the MSCI Frontier Markets Index (Total Return Net), it does not try to replicate this benchmark and freely selects the securities that it invests in. The deviation with this benchmark can be significant. Intended retail investor

This fund may not be appropriate for investors who plan to withdraw their money within 5-10 years.

Dividend income: This class is a capitalisation class meaning that income is reinvested

**Risk indicator**

This rates the potential losses from future performance at a medium level, and poor market conditions could impact our capacity to pay you.

#### What happens if East Capital is unable to pay out?

If we are not able to pay you out what we owe you, you are not covered by any national compensation or guarantee scheme. To protect you, the assets are held with a separate company, the depositary Skandinaviska Enskilda Banken. AB (publ) – Luxembourg Branch. Should we default, the investments are liquidated and the proceeds are distributed to the investors. In the worst case, however, you could lose your entire investment.

### What are the costs?

#### Costs over time
