What is this product?

The product is an undertaking for collective investment in transferable securities (UCITS, fund) in accordance with the Investment Fund Act 2011 (InvFG). The Fund is a portfolio of assets with no legal personality that is divided into equal units represented by securities and that is collectively owned by all unit-holders.

Torm

The Fund was established for an indefinite period of time.

The Management Company may terminate the management of the Fund or merge the Fund with another fund, both in compliance with the applicable legal regulations (see the prospectus, section II, item 7). If the unit-holders redeem all units in the Fund, the Fund will also be terminated.

Objectives

ERSTE BOND USA HIGH YIELD is a bond fund. The Fund aims to achieve capital growth and/or continuous returns.

The unit category ERSTE BOND USA HIGH YIELD HUF DO2 was issued solely for purchases relating to individual portfolio management mandates outside of Austria by asset managers belonging to Erste Group, as well as for purchases relating to online-based individual portfolio management mandates conducted by Erste Group. Before the first purchase, the asset manager must provide assurance of sole use for an individual portfolio management mandate. There is no minimum (initial) investment volume.

The unit certificate transactions are settled in HUF. No additional hedges are employed to cover currency risks versus the fund currency EUR. Therefore, there is the risk of currency losses.

In order to attain the investment objective, the Fund invests predominantly, in other words at least 51% of its assets, in bonds from North American companies without limitations on sectors of activity in the form of directly purchased instruments, in other words not indirectly or directly through funds or derivatives; the bonds must predominantly be denominated in USD and must be in the speculative grade (high yield) segment in terms of the ratings assigned by recognised rating agencies. Foreign currency risks are hedged versus the euro to the greatest extent possible using suitable strategies.

Units in investment funds may comprise up to 10% of the fund assets per fund and up to 10% in aggregate total.

Derivative financial instruments can be used as part of the investment strategy and for hedging purposes, and may comprise up to 35% of the fund assets. The Fund employs an active investment policy and is not oriented towards a benchmark. The assets are selected on a discretionary basis, and the Management Company's degree of freedom is not limited.

Intended retail investor

This product is intended for investors with basic knowledge and with no or only limited experience with investing in funds, who wish to increase the value of their investment over the recommended holding period and/or who are seeking regular returns, and who are also willing to accept a potential financial loss in terms of their originally invested capital.

Additional information

This Fund is divided into unit classes. Information on the other unit classes can be found in the prospectus (section II, item 7).

You can demand the redemption of your fund units on any Austrian exchange trading day with the exception of bank holidays.

The Management Company can suspend redemption if this is deemed prudent based on exceptional circumstances.

The income of the Fund is retained in the Fund for the unit class (VTIA) and increases the value of the units. The taxation of income or capital gains from the Fund depends on your personal tax circumstances. If you have any questions, you should seek professional advice.

The risk indicator assumes you will keep the product for at least 6 years.

What happens if Erste Asset Management GmbH is unable to pay out?

The Fund is a portfolio of assets that is segregated from the assets of the Management Company. The Fund is not subject to any legal or other deposit quarantee scheme.

How long should I hold it and can I take money out early?

Recommended holding period: 6 years

You should be willing to hold your investment for at least 6 year/years. This recommended holding period is based on our assessment of the risk and reward characteristics and costs of the Fund. However, losses cannot be ruled out.

You can demand the redemption of your fund units on any Austrian exchange trading day with the exception of bank holidays. For further information, see the prospectus, section II, item 10.

The redemption price is the unit value rounded down to the next equivalent sub-unit of the currency unit specified for the respective unit class in the prospectus. The unit value is calculated in HUF. The Management Company charges no redemption fee.

The Management Company can suspend redemption if this is deemed prudent based on exceptional circumstances.
