## What is this product?

### Type

The product is a share of the sub-fund Franklin European Total Return Fund (the "Fund") which is part of Franklin Templeton Investment Funds, an open-ended investment company with variable capital (SICAV), qualifying as a UCITS.

### Term

The Fund has no maturity date. The Fund could be closed under the conditions laid down in the current prospectus of the Fund.

### Objectives

#### Investment Objective

The Fund is classified as Article 8 under EU Sustainable Finance Disclosure Regulation and aims to maximise total investment return by achieving an increase in the value of its investments, earning income and realising currency gains over the medium to long term.

#### Investment Policy

The Fund pursues an actively managed investment strategy and invests mainly in:

- higher-quality debt securities issued by governments, government-related entities and corporations located in Europe and/or in euro-denominated securities of non-European issuers

The Fund can invest to a lesser extent in:

- debt securities of any quality (including lower quality) and denominated in any currency from issuers of any type located outside Europe, including emerging markets
- debt securities of supranational entities, such as the European Investment Bank
- structured products such as mortgage- and asset-backed securities, collateralized debt obligations and collateralized loan obligations
- securities in default (limited to 10% of assets)
- convertible securities and up to 5% of the Fund's assets in contingent convertible securities
- derivatives for hedging and efficient portfolio management

The Fund employs a binding environmental, social and governance (ESG) rating methodology to assess climate transition performance of government and corporate bond issuers. The Fund uses a selectivity approach in order

to exclude from its portfolio issuers that score in the bottom 20% of each respective investment universe. The Fund's ESG strategy includes working with companies to improve their carbon emissions, water and wastewater strategies. The Fund also applies specific exclusions and will not invest, inter alia, in companies that repeatedly and/or seriously violate the United Nations Global Compact, manufacture controversial weapons or tobacco, or exceed certain thresholds on the use of fossil fuels.

The Fund may distribute income gross of expenses. Whilst this might allow more income to be distributed, it may also have the effect of reducing capital.

The benchmark of the Fund is the Bloomberg Euro Aggregate Index. The benchmark is used solely as a reference for investors to compare against the Fund's performance, and the benchmark is neither used as a constraint on how the Fund's portfolio is to be constructed nor set as a target for the Fund's performance to beat. The Fund can deviate from the benchmark.

#### Share Class Policy

The income received from the Fund's investments is accumulated with the result of increasing the value of the shares.

For this share class, the manager applies a portfolio hedge that is intended to minimize the currency risk between the currency of the share class (which is in a non-base currency) and the base currency of the Fund.

#### Processing of subscription and redemption orders

You may request the sale of your shares on any Dealing Day.

#### Intended retail investor

The Fund may appeal to investors looking to maximise their investment return with a combination of income, capital appreciation and currency gains by obtaining exposure to debt securities issued by European governments or corporate issuers and willing to hold their investment over the medium to long term for a minimum period of 3 to 5 years. The Fund is suitable for investors who do not need to have specific knowledge and/or experience of financial markets with the understanding that they may not get back the full amount invested in the Fund.

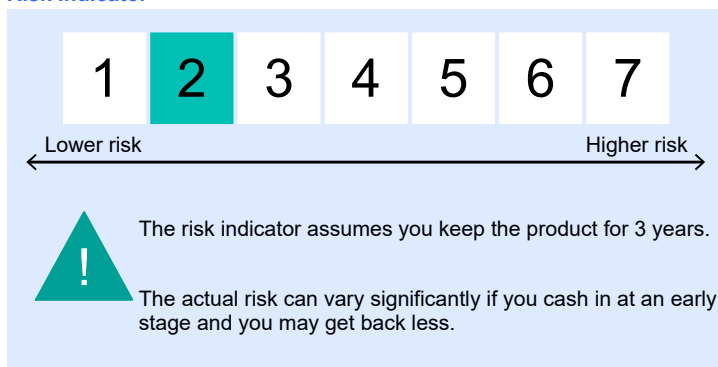

## What are the risks and what could I get in return?

### Risk Indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets.

We have classified this product as 2 out of 7, which is a low risk class. Due to the nature of the Fund's investments, the Fund's performance can fluctuate to a small degree over time.

**Be aware of currency risk.** You will receive payments in a different currency, so the final return you will get depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

## What happens if Franklin Templeton International Services S.à r.l. is unable to pay out?

Franklin Templeton International Services S.à r.l. ("FTIS") is the management company of the Fund. The assets of the Fund are held separately by the Fund's appointed depositary, i.e. J.P. Morgan SE, Luxembourg branch. The depositary is liable to the Fund or its shareholders for losses caused by its negligent or intentional failure to fulfill its safekeeping or record-keeping obligations. (Cash could however be lost in case of default of the depositary or its delegates).

There is no compensation or guarantee scheme protecting you from a default of the Fund's depositary.

## What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

### Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario
- NOK 100,000 is invested
