What is this product?

The product is a share of the sub-fund Franklin Income Fund (the "Fund") which is part of Franklin Templeton Investment Funds, an open-ended investment company with variable capital (SICAV), qualifying as a UCITS.

The Fund has no maturity date. The Fund could be closed under the conditions laid down in the current prospectus of the Fund.

Objectives Investment Objective

The Fund aims to earn income and, secondarily, to increase the value of its investments over the medium to long term.

Investment Policy

The Fund pursues an actively managed investment strategy and invests mainly in:

• equity and equity-related securities (including equity-linked notes) issued by companies located in, or doing significant business in, the U.S.

 debt securities of any quality (including lower quality) issued by corporations and governments

The Fund can invest to a lesser extent in:

 equity and debt securities traded in the U.S. and issued by corporations located anywhere in the world (limited to 25% of assets)

• equity or debt securities issued by corporations that entitle the holder to receive equity or debt securities of another corporation located anywhere in the world (limited to 25% of assets)

 derivatives for hedging, efficient portfolio management and/or investment purposes

The Fund may distribute income gross of expenses. Whilst this might allow more income to be distributed, it may also have the effect of reducing capital.

What are the risks and what could I get in return?

The risk indicator assumes you keep the product for 3 years.

What happens if Franklin Templeton International Services S.à r.l. is unable to pay out?

Franklin Templeton International Services S.à r.l. ("FTIS") is the management company of the Fund. The assets of the Fund are held separately by the Fund's appointed depositary, i.e. J.P. Morgan SE, Luxembourg branch. The depositary is liable to the Fund or its shareholders for losses caused by its negligent or intentional failure to fulfill its safekeeping or record-keeping obligations. (Cash could however be lost in case of default of the depositary or its delegates).

What are the costs?

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

• In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario
