### What is this product?

#### Type

The product is a share class of the sub-fund Franklin K2 Alternative Strategies Fund (the "Fund") which is part of Franklin Templeton Investment Funds, an open-ended investment company with variable capital (SICAV), qualifying as a UCITS.

#### Term

The Fund has no maturity date. The Fund could be closed under the conditions laid down in the current prospectus of the Fund. **Objectives** 

### Investment Objective

The Fund is classified as Article 8 under EU Sustainable Finance Disclosure Regulation and aims to increase the value of its investments over the medium to long term and to keep share price fluctuations lower than those for equity markets generally.

#### Investment Policy

The Fund can invest in any asset, and use any investment technique, that is permitted to a UCITS fund, including those that are generally considered to be high risk.

The Fund can invest in any kind of equity securities and debt securities from any country or type of issuer. It can invest directly or may gain exposure to investments indirectly, such as through derivatives, participatory notes, or by investing in other UCITS or UCIs. It can take direct or indirect long or short positions in securities, currencies, interest rates, and other investments or financial instruments. It may also take indirect long or short positions in commodities. The Fund may engage in derivative transactions that have the effect of magnifying investment gains or losses. The Fund uses high quantity of listed and unlisted derivatives for hedging, efficient portfolio management and/or investment purposes. The Fund may engage in active and frequent trading as part of its investment strategies. The Fund may also invest up to 10% of its net assets into risk-linked securities, of risks from an issuer to investors ("catastrophe bonds").

The lead manager assigns portions of the Fund's assets to multiple outside management teams (selected and monitored by the lead manager), each of which uses an alternative investment strategy to manage its portion. These strategies may seek to benefit from, for instance, global economic trends, corporate mergers or reorganizations, pricing variations between markets or securities, industries or geographic regions with above-average growth. The Fund's overall performance will be the result of the performance of the different strategies involved and the portion of the Fund's assets assigned to such strategies. The Fund may also invest up to 10% of its assets in securities issued by private companies and Private Investments in Public Equity and up to 5% in special purpose acquisition companies.

The Fund may hold significant amounts of bank deposits, money market instruments or money market funds due to the use of derivatives or in order to achieve its investment goals and for treasury purposes.

**Benchmarks:** ICE BofA US 3-Month Treasury Bill Index and HFRX Global Hedge Fund Index. The benchmarks are used solely as a reference for Investors to compare against the Fund's performance. The Fund is not obliged to hold any of the benchmarks constituents and may indeed invest up to 100% of its net assets outside these benchmarks.

#### Share Class Policy

The income received from the Fund's investments is accumulated with the result of increasing the value of the shares.

For this share class, the manager applies a portfolio hedge that is intended to minimize the currency risk between GBP (the base currency of the fund) and the positions in the portfolio (which are managed from a USD perspective).

#### Processing of subscription and redemption orders

You may request the sale of your shares on any Dealing Day (as defined in the current prospectus of the Fund).

#### Intended retail Investor

The Fund may appeal to investors looking to capital appreciation by obtaining exposure to a wide range of eligible securities and derivative instruments benefiting from several "alternative" strategies and willing to hold their investment over the medium to long term for a minimum period of 3 to 5 years. The Fund is suitable for investors who have some knowledge and/or experience of financial markets with the understanding that they may not get back the full amount invested in the Fund. **Depositary**

# What are the risks and what could I get in return?

#### **Risk Indicator**





The risk indicator assumes you keep the product for 3 year(s).

### What happens if Franklin Templeton International Services S.à r.l. is unable to pay out?

Franklin Templeton International Services S.à r.I. ("FTIS") is the management company of the Fund, but the assets of the Fund are held separately from FTIS by the depositary. J.P. Morgan SE, Luxembourg branch, as the appointed depositary, is liable to the Fund or its shareholders for losses caused by its negligent or intentional failure to fulfill its safekeeping or record-keeping obligations (cash could however be lost in case of default of the depositary or its delegates).

There is no compensation or guarantee scheme protecting you from a default of the Fund's depositary.

### What are the costs?
