## What is this product?

#### Туре

The product is a share class of the sub-fund Franklin Mutual European Fund (the "Fund") which is part of Franklin Templeton Investment Funds, an open-ended investment company with variable capital (SICAV), qualifying as a UCITS.

Term The Fund has no maturity date. The Fund could be closed under the conditions laid down in the current prospectus of the Fund.

#### Objectives Investment Objective

Franklin Mutual European Fund (the "Fund") is classified as Article 8 under EU Sustainable Finance Disclosure Regulation and aims to increase the value of its investments and, secondarily, to earn income over the medium to long term.

### Investment Policy

The Fund pursues an actively managed investment strategy and invests mainly in:

equity securities issued by companies of any size located in European countries

The Fund can invest to a lesser extent in:

• equity securities issued by companies involved in mergers, consolidations, liquidations or other major corporate transactions

 debt securities of any quality (including lower quality debt such as noninvestment grade securities) of companies involved in reorganisation or financial restructuring

• securities of non-European issuers (up to 10% of assets)

• derivatives for hedging, efficient portfolio management and/or investment purposes

Although the Fund generally invests in at least five countries, it may invest in as few as one or two. The Fund currently intends to invest principally in securities of issuers in western Europe. The investment team uses in-depth, fundamental research and analysis to find and purchase those equity and debt securities that are believed to be trading at a discount.

The environmental and social characteristics promoted by the Fund include, among other things, the reduction of greenhouse gas ("GHG") intensity and board gender diversity. The Fund commits to maintaining a portfolio GHG intensity (scope 1+2), at least 20% below that of the Benchmark and of the investment universe, whichever is the lowest. The Fund also applies specific sustainability-related exclusions.

The benchmark of the Fund is the Linked MSCI Europe Value Index-NR. The benchmark is used solely as a reference for Investors to compare against the Fund's performance, and the benchmark is neither used as a constraint on how the Fund's portfolio is to be constructed nor set as a target for the Fund's performance to beat. The Fund can deviate from the benchmark.

#### Share Class Policy

For the distribution share class shown in this document, dividend income is distributed to shareholders.

Processing of subscription and redemption orders

You may request the sale of your shares on any Dealing Day (as defined in the current prospectus of the Fund).

#### Intended retail Investor

The Fund may appeal to investors looking to capital appreciation and to a lesser extent, income by obtaining exposure to equity securities of undervalued companies of any European country and willing to hold their investment over the medium to long term for a minimum period of 3 to 5 years. The Fund is suitable for investors who do not need to have specific knowledge and/or experience of financial markets with the understanding that they may not get back the full amount invested in the Fund.

## What are the risks and what could I get in return?

## **Risk Indicator**



The risk indicator assumes you keep the product for 5 year(s).

# What happens if Franklin Templeton International Services S.à r.l. is unable to pay out?

Franklin Templeton International Services S.à r.I. ("FTIS") is the management company of the Fund, but the assets of the Fund are held separately from FTIS by the depositary. J.P. Morgan SE, Luxembourg branch, as the appointed depositary, is liable to the Fund or its shareholders for losses caused by its negligent or intentional failure to fulfill its safekeeping or record-keeping obligations (cash could however be lost in case of default of the depositary or its delegates).

There is no compensation or guarantee scheme protecting you from a default of the Fund's depositary.

## What are the costs?

### Costs over Time

This Fund has no minimum required holding period. We consider that the 5 year recommended holding period is appropriate because the Fund is designed for long-term investment.
