Objectives and Investment Policy

Franklin U.S. Low Duration Fund (the "Fund") aims to earn high income while preserving investors' capital over the medium term.

The Fund pursues an actively managed investment strategy and invests mainly in:

 higher-quality debt securities issued by the U.S. government and its agencies (up to 100% of the Fund's assets), and by corporations located in the U.S., including mortgage- and asset-backed securities

The Fund can invest to a lesser extent in:

- · debt securities of issuers located in other countries (limited to 25% of
- non-Ú.S. dollar investments (limited to 20% of assets)
- lower-quality debt securities (limited to 20% of assets)
 Mainland China through the Bond Connect or directly (limited to 5% of assets)

The Fund can use derivatives for hedging, efficient portfolio management and/or investment purposes.

The investment team focuses on securities and industry sectors that it believes will provide the best opportunities over the long term.

The Fund aims to maintain an average duration of less than three years.

The benchmark of the Fund is the Hybrid: Bloomberg US Treasury (1-3 Y) Index to 30 Sep 2014 then Bloomberg US Government & Credit (1-3 Y) Index. The benchmark is used solely as a reference for Investors to compare against the Fund's performance, and the benchmark is neither used as a constraint on how the Fund's portfolio is to be constructed nor set as a target for the Fund's performance to beat. Terms to Understand

Asset-backed securities: Debt securities whose value and income payments are derived from a pool of underlying assets.

Average duration: A measure of the sensitivity of a debt security portfolio to interest-rate changes.

Derivatives: Financial instruments whose characteristics and value depend on the performance of one or more underlying assets, typically securities, indexes, currencies or interest rates.

Hedging: A strategy for totally or partially offsetting particular risks such as those arising from fluctuations in share prices, currencies or interest rates.

Mortgage-backed securities: Securities whose value and income payments are derived from the ownership of a pool of underlying mortgage debts.

Why is the Fund in this specific category?

The Fund invests in relatively short-term debt securities mainly in the U.S., but may invest up to 25% in non-U.S. issuers. Such securities have historically been subject to price movements, generally due to interest rates or movements in the bond market. As a result, the performance of the Fund can fluctuate moderately over time.

Risks materially relevant not adequately captured by the indicator:

Credit risk: the risk of loss arising from default that may occur if an issuer fails to make principal or interest payments when due. This risk is higher if the Fund holds low-rated, sub-investment-grade securities.

Derivative Instruments risk: the risk of loss in an instrument where a small change in the value of the underlying investment may have a larger impact on the value of such instrument. Derivatives may involve additional liquidity, credit and counterparty risks.

Foreign Currency risk: the risk of loss arising from exchange-rate fluctuations or due to exchange control regulations.

Liquidity risk: the risk that arises when adverse market conditions affect the ability to sell assets when necessary. Such risk may be triggered by (but not limited to) unexpected events such as environmental disasters or pandemics. Reduced liquidity may have a negative impact on the price of the assets
