## What is this product?

### Type

Shares of a sub-fund of Fidelity Funds SICAV, an Undertaking for Collective Investment in Transferable Securities (UCITS).

**SFDR product category:** Article 8 (promotes ESG characteristics).

### Term

This fund is open-ended.

### Objectives

**Objective:** The fund aims to achieve capital growth over time and provide a high level of income.

**Investment Policy:** The fund invests at least 70% of its assets, in high-yielding below investment grade bonds of issuers anywhere in the world, including emerging markets. The fund may also invest in money market instruments, on an ancillary basis. The fund may invest in the following assets according to the percentages indicated:

Listed China onshore bonds (directly and/or indirectly): less than 30% (in aggregate)

hybrids and contingent convertible (CoCo) bonds: less than 30%, with less than 20% in CoCos

The fund may also invest in other subordinated financial debt and preference shares.

The fund will invest in a limited number of securities resulting in portfolio concentration.

The fund's exposure to distressed securities is limited to 10% of its assets.

**Investment Process:** In actively managing the fund, the Investment Manager uses in-house research and investment capabilities to identify suitable opportunities across bond issuers, sectors, geographies and security types. This may include an assessment of bond issuers' creditworthiness, macroeconomic factors, and valuations. The Investment Manager considers ESG factors when assessing investment risks and opportunities. In determining ESG factors, the Investment Manager takes into account ESG ratings provided by Fidelity or external agencies.

The fund aims to achieve an ESG score of its portfolio greater than that of its benchmark. Through the investment management

process the Investment Manager aims to ensure that investee issuers follow good governance practices.

**Derivatives and Techniques:** The fund may use derivatives for hedging, efficient portfolio management and investment purposes.

**Benchmark:** ICE BofA Q788 Custom Index (a custom blend of high yield indices), a broad market index that does not take into account ESG characteristics. Used for: risk monitoring, investment selection and performance comparison.

**Risk Management Method:** Commitment.

This product may appeal to investors with a basic knowledge of and no or limited experience of investing in funds; who plan to hold their investment for a recommended holding period of at least 3 years; who seek capital growth over the recommended holding period and income; and who understand the risk of losing some or all of the capital invested.

## What are the risks and what could I get in return?

### Risk Indicator



The risk indicator assumes you keep the product for 3 years.
