Objectives and Investment Policy

Objective: The fund aims to achieve capital growth over time and provide a high level of income.

Investment Policy: The fund invests at least 70% of its assets, in hybrids and contingent convertible (CoCo) bonds, subordinated financial debt and preference shares from anywhere in the world, including emerging markets. Some of these investments may be below investment grade.

The fund invests at least 50% of its assets in securities of issuers with favourable environmental, social and governance (ESG) characteristics.

The fund may also invest in other transferable securities, UCITS/UCIs, money market instruments, cash and term deposits. The fund's exposure to distressed securities is limited to 10% of its assets.

Investment Process: In actively managing the fund, the Investment Manager uses in-house research and investment capabilities to identify suitable opportunities across bond issuers, sectors, geographies, and security types. This may include an assessment of bond issuers' creditworthiness, macroeconomic factors, and valuations. The Investment Manager also considers ESG characteristics when assessing investment risks and opportunities. In determining favourable ESG characteristics, the Investment Manager takes into account ESG ratings provided by Fidelity or external agencies. Through the investment management process, the Investment Manager aims to ensure that investee issuers follow good governance practices.

The fund adheres to the Fidelity Sustainable Investing Framework standards. For more information, see "Sustainable Investing and ESG Integration".

Derivatives and Techniques: The fund may use derivatives for hedging, efficient portfolio management and investment purposes.

Benchmark: 50% ICE BofA Contingent Capital Index + 50% ICE BofA Global Hybrid Corporate Index, indices that do not take into account ESG characteristics. Used for: investment selection, risk monitoring, and performance comparison.

Risk Management Method: Commitment.

Base Currency: EUR.

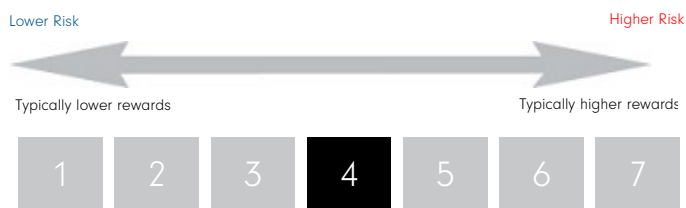
Distribution: As this is a non-distributing share class, dividends are re-invested.

Investments may be made in currencies other than the fund's reference currency. Exposure to currencies may be hedged, for example with currency forward contracts. The fund's reference currency is the currency used for reporting and may be different from the currency of denomination of the investments.

Currency hedging is used to substantially reduce the risk of losses from unfavourable exchange rate movements. Currency look-through hedging is used to hedge the underlying currency effects to that of the hedged share class reference currency, thereby delivering the underlying market returns. In order to preserve returns from any active currency positions in the fund,

such exposures are hedged with reference to the currency weights of a comparison index rather than to the currency denominations of the underlying securities.

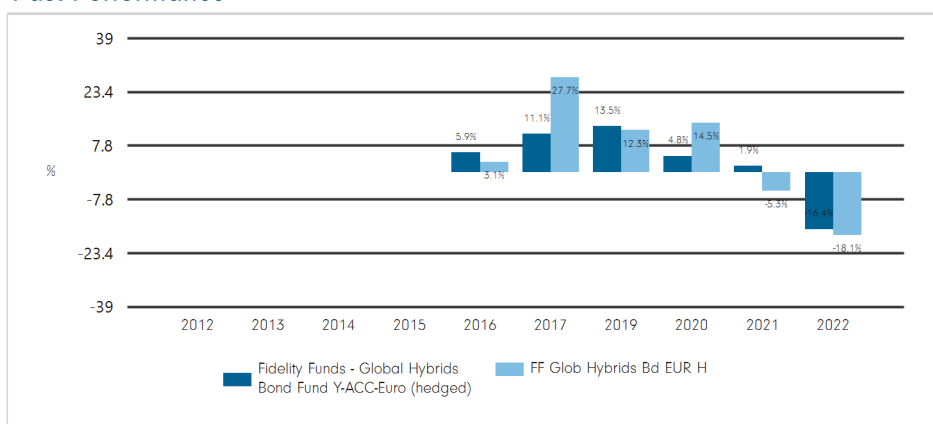
