Objectives and Investment Policy

- The fund aims to provide long-term capital growth with the level of income expected to be low.
- The fund will invest at least 70% in shares of companies not engaged in real estate business, which are resident in Italy or in another EU or EEA Member State with a permanent establishment in Italy.
- The fund cannot invest more than 10% of its assets in financial instruments issued by, or entered into with the same company, or companies belonging to the same group, or in cash deposits. The fund cannot invest in financial instruments issued by, or entered into with, companies which are not resident in countries that allow an adequate exchange of information with Italy.
- The fund will invest at least 50% of its net assets in securities that maintain sustainable characteristics. The fund promotes environmental and social characteristics pursuant to article 8 of the SFDR.
- The fund adheres to the firm-wide exclusion list (which includes cluster munitions and anti-personnel landmines) and also excludes issuers which fail to conduct their business in accordance with accepted international norms.
- The fund has the freedom to invest outside its principal geographies, market sectors, industries or asset classes.
- Investment in derivatives are permitted only outside the above 70% threshold and exclusively for hedging purposes.
- The fund is actively managed and references FTSE Italia All Share Index (Net) (the 'Index'), for comparative purposes only.
- Income earned by the fund is accumulated in the share price.
- Shares can usually be bought and sold each business day of the fund.
- Shares are eligible investments for a "Piano Individuale di Risparmio a lungo termine" (PIR) without prejudice to the investment restrictions set out in Part V of the Prospectus and in accordance with the Italian Law No.232 of 11 December 2016 (as amended).
- The fund will invest at least 17.5% of its assets in securities issued by companies which are not listed in the FTSE MIB index or in any equivalent indices and at least 3.5% of its assets in securities issued by companies which are not listed in the FTSE MIB index, FTSE Mid Cap index or in any equivalent indices.
