## What is this product?

### Type

Shares of a sub-fund of Fidelity Funds 2 SICAV, an Undertaking for Collective Investment in Transferable Securities (UCITS).

**SFDR product category:** Article 8 (promotes environmental and/or social characteristics).

### Term

This fund is open-ended.

### Objectives

**Objective:** The fund aims to achieve capital growth over time.

**Investment Policy:** The fund invests at least 70% of its assets, in equities of small and medium sized companies from anywhere in the world.

The fund may invest in the following assets according to the percentages indicated:

Money market instruments: up to 20%

China A and B shares (directly and/or indirectly): less than 10% (in aggregate)

Emerging markets (including China): up to 10%

**Investment Process:** In actively managing the fund, the Investment Manager considers growth and valuation metrics, company financials, return on capital, cash flows and other measures, as well as company management, industry economic conditions, and other factors. The Investment Manager considers ESG characteristics when assessing investment risks and opportunities. In determining ESG characteristics, the Investment Manager takes into account ESG ratings provided by Fidelity or external agencies. The fund aims to achieve an ESG score of its portfolio greater than that of its benchmark. Through the investment management process the Investment Manager aims to ensure that investee companies follow good governance practices. **Derivatives and Techniques:** The fund may use derivatives for hedging, efficient portfolio management and investment purposes.

**Benchmark:** MSCI World Mid Cap Index, a broad market index

The fund invests in securities of the benchmark, however, management of the fund is discretionary, therefore the fund may invest in securities not included in the benchmark, and its performance over any period may or may not deviate significantly from that of the benchmark.

**Investor Profile:** This product may appeal to investors: with a basic knowledge of and no or limited experience of investing in funds; who plan to hold their investment for a recommended holding period of at least 5 years; who seek capital growth over the recommended holding period; and who understand the risk of losing some or all of the capital invested.

## What are the risks and what could I get in return?

### Risk Indicator



The risk indicator assumes you keep the product for 5 years.
