What is this product?

Type

Shares of a sub-fund of Fidelity UCITS ICAV, an Undertaking for Collective Investment in Transferable Securities (UCITS ETF).

SFDR product category: Article 8 (promotes ESG characteristics).

Term

This fund is open-ended.

Objectives

Objective: The fund aims to provide investors with a total return, taking into account both capital and income returns, which reflects, before fees and expenses, the return of the Fidelity Metaverse ESG Tilted Index NR (the "Index").

Investment Policy: The investment policy of the fund is to track the performance of the Index as closely as possible, regardless of whether the Index level rises or falls, while seeking to minimise as far as possible the tracking error between the fund's performance and that of the Index.

The fund will aim to replicate the Index by holding all of the Index securities in a similar proportion to their weighting in the Index.

The fund may use derivatives for efficient portfolio management and currency hedging purposes.

Investment Process: The fund uses a benchmark "index tracking" (also known as "passive") investment management approach by tracking the Index.

The Index is designed to reflect the performance of The Index is designed to reflect the performance of a global universe of companies that develop, manufacture, distribute, sell products or services related to establishing and enabling the "Metaverse", which is a term used to describe a future state of the internet characterized by a network of both augmented reality and virtual worlds that can be experienced persistently and in a shared environment by large numbers of users (the "Index Theme"). The Index comprises equity securities of the relevant companies.

To be eligible to be included in the Index, stocks must pass a screen particular to the Index Theme, meeting certain theme-specific criteria.

The Index also applies environmental, social and governance (ESG) screens and integrates ESG rating in the index construction

as part of its methodology so that a minimum of 50% of its constituents are deemed to maintain favourable ESG characteristics.

The Index also applies an ESG controversies screen to exclude certain issuers based on data rating controversies depending on their impact on the environment and society as well as the risks to the issuer's business.

What are the risks and what could I get in return?

Risk Indicator



The risk indicator assumes you keep the product for 4 years.
