# What is this product?

#### Type:

The Fund is a sub-fund of the Magna Umbrella Fund Plc, an open-ended variable capital umbrella investment company with limited liability and segregated liability between Funds incorporated under the laws of Ireland with registered number 277318 and authorised as an undertaking for collective investment in transferable securities pursuant to the European Communities (UCITS) Regulations, 2011 (S.I Number 352 of 2011), as amended. The Magna Umbrella Fund Plc is authorised in Ireland by the Central Bank of Ireland.

#### Term:

The Fund is not subject to any fixed term.

#### **Objectives:**

The investment objective of the Fund is to deliver annualised double digit returns (10% or greater) before fees and costs, with lower risk of capital loss than broader global equity markets, over the long term by investing in a portfolio of listed equities and holding them generally for an investment horizon of over 5 to 7 years.

The Investment Manager expects that a minimum of 80% of the Fund's portfolio will generally consist of long positions in global publicly listed equities. The Investment Manager anticipates that the portfolio of the Fund will, under typical market conditions, contain between 25 and 35 positions in global exceptional companies with strong wealth creation credentials.

The Fund will seek to maintain a diversified portfolio through investing in issuers of companies with a range of end markets and end customers and among a diversified selection of sectors. When considering investments for the Fund, the Investment Manager will consider the long-term objective of achieving superior and sustainable returns.

The Fund is considered to be actively managed in reference to the MSCI All-Country World Index ("Benchmark") by virtue of the fact that it uses the Benchmark for performance comparison purposes. However, the Benchmark is not used to define the portfolio composition of the Fund or as a performance target and the Fund may be wholly invested in securities which are not constituents of the Benchmark.

The base currency of the Fund is USD. Any non-base currency share classes will be currency hedged against the currency exposure between the denominated currency of the class and the base currency of the Fund.

The share class does not pay any distributions or other periodic compensation during its lifetime.

You may redeem your Shares in the Fund on any day on which banks in Dublin, London and New York are open for business.


#### **Intended Retail Investor:**
