What is this product?

The information contained in this document and the methodologies for calculating risks, costs and potential returns are prescribed by law.

Forward Lucy Global Sustainable Equity Strategy (the "Sub-Fund") is a Sub-Fund of the FWU Protection Fund SICAV, an umbrella fund incorporated in 2017 as a public limited company under the laws of Luxembourg as an investment company with variable share capital. The Fund is subject to Part I of the Luxembourg law of 17 December 2010 relating to undertakings for collective investment (UCITS), as amended or supplemented from time to time. The Fund has been authorised by the Commission de Surveillance du Secteur Financier (CSSF) which is the Luxembourg supervisory authority of the financial sector. The Depositary Bank is RBC Investor Services Bank S.A. of 14, Porte de France, L-4360 Esch-sur-Alzette, Grand Duchy of Luxembourg.


The Sub-Fund seeks to maximise long-term capital growth by investing primarily in equities of companies that are domiciled in major developed markets across the World, and which behave in a sustainable way, as defined by Environmental, Governmental and Social (ESG) factors. The Sub-Fund aims to achieve its investment objective through direct investments in equities traded on Regulated Markets or on markets that are regulated, operate regularly and are recognised and open to the public, while bindingly integrating ESG criteria in the investment selection process. The Sub-Fund will have a strong focus on Sustainable investing, and as such every selected asset will be in-line with this philosophy. In addition, the Sub-Fund aims to make sustainable investments (within the meaning of article 2 (17) of the SFDR) that contribute to the sustainable investment objective of climate change mitigation. The Sub-Fund also aims to predominantly invest in companies with a high level of alignment with the EU Taxonomy.

The benchmark used by the Sub-Fund for performance comparison is MSCI World ESG Leaders Net Total Return Index (USD).

What are the risks and what could I get in return?

What happens if FWU Invest is unable to pay out?

The investors of this product will not face financial loss due to the default of the FWU Protection Fund SICAV, as the Sub-fund is considered to be a separate entity with segregated assets.

What are the costs?

The annual cost impact shows what impact the total costs you pay, will have on the investment return you might get. The total costs take into account one-off, ongoing, and incidental costs. The amounts shown here are the cumulative costs of the product itself, for two different holding periods and in each case based on the moderate scenario set out in the performance scenarios. The figures assume you invest EUR 10,000. The figures are estimates and may change in the future.
