What is this product?

Туре

The product is a share class of FTGF ClearBridge US Value Fund (the "Fund") which is part of the Franklin Templeton Global Funds plc, an investment company with variable capital incorporated with limited liability in Ireland and established as an umbrella fund with segregated liability between sub-funds.

Term

The Fund has no maturity date. The Fund could be closed under the conditions laid down in the current prospectus of the Fund.

Objectives Investment Objective

The Fund seeks to achieve long-term capital appreciation by investing principally in securities of US Issuers, which the Investment Manager

believes are undervalued. Investment Policy

• The Fund will mostly invest in shares of US companies.

 The Fund will invest in shares of companies that in the portfolio managers' opinion are undervalued.

• The Fund generally invests in companies with market capitalisations greater than US\$5 billion. The Fund may also invest up to 20% in companies outside of the US. The Fund may also invest in debt securities including government, corporate and short-term securities including debt securities which are below investment grade or, if unrated by an NRSRO, deemed by the investment manager to be of comparable quality.

• The Fund may invest in derivatives (financial instruments whose value is derived from the value of other assets), to help try to achieve the Fund's objective as well as to reduce risk or cost or to generate additional growth or income for the Fund.

• This is an Article 8 fund under the EU Sustainable Finance Disclosure Regulation.

• Benchmark: Russell 1000 Value Index

• Manager's Discretion: The Fund is actively managed. The investment manager has discretion in selecting investments within the Fund's objective and investment policies. The benchmark is used for performance comparison purposes. While many of the Fund's securities will be components of the benchmark, the weightings of the holdings may differ materially from the weightings in the benchmark. The Fund's percentage exposures to sectors and industries may differ materially from those of the benchmark.

• Transaction Costs: The Fund bears costs in buying and selling investments, which may have a material impact on the Fund's performance. Share Class Policy

Income and gains f rom the Fund's investments are not paid but instead are reflected in the Fund's share price.

Intended retail Investor

The Fund may appeal to investors looking to achieve capital appreciation by obtaining exposure to equity securities of US issuers which the investment manager believes are undervalued. Investors should be willing to hold their investment over the long term for a minimum period of 5 to 7 years. The Fund is suitable for investors who do not need to have specific knowledge and/or experience of financial markets with the understanding that they may not get back the full amount invested in the Fund.



What are the risks and what could I get in return?

Risk Indicator



The actual risk can vary significantly if you cash in at an early stage and you may get back less.

What happens if Franklin Templeton International Services S.à r.l. is unable to pay out?

Franklin Templeton International Services S.à r.l. ("FTIS") is the management company of the Fund, but the assets are held separately from FTIS by the depositary. BNY Mellon SA/NV Dublin Branch, as the appointed depositary of the Fund, is liable to the Fund or its shareholders for any loss of financial instruments held in custody by it or its delegates (cash could however be lost in case of default of the depositary or its delegates).

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

• In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario
