### What is this product?

#### Туре

The product is a share class of FTGF Royce US Small Cap Opportunity Fund (the "Fund") which is part of the Franklin Templeton Global Funds plc, an investment company with variable capital incorporated with limited liability in Ireland and established as an umbrella fund with segregated liability between sub-funds.

Term

The Fund has no maturity date. The Fund could be closed under the conditions laid down in the current prospectus of the Fund.

#### Objectives Investment Objective

The Fund seeks to achieve long-term capital appreciation.

Investment Policy

• The Fund invests at least 70% of its net asset value in a diversified portfolio of equity securities issued by small-cap and micro-cap US companies (i.e., US companies with stock market capitalisations not greater than that of the largest company (based on market capitalisation) in the Russell 2000 Index at the time of its most recent reconstitution) that are listed or traded on regulated markets in the United States.

• The Fund will invest in shares of companies that the portfolio managers believe are undervalued.

• Benchmark: Russell 2000 Value Index

# What are the costs?

### Costs over Time
