### Objectives and Investment Policy

Franklin Strategic Income Fund (the "Fund") aims to earn high income and, secondarily, to increase the value of its investments over the medium to long term.

The Fund invests mainly in:

- debt securities of any quality issued by governments and corporations located in any country, including emerging markets, and in mortgage- and asset-backed securities

The Fund can invest up to 100% of its assets in low-rated or unrated debt securities and up to 100% of its net assets in securities of companies that are, or are about to be, involved in reorganisations, financial restructurings or bankruptcy.

The Fund can invest to a lesser extent in:

- securities in default (limited to 10% of assets)
- units of other mutual funds (limited to 10% of assets)

The Fund can use derivatives for hedging, efficient portfolio management and/or investment purposes.

The Fund may distribute income gross of expenses. Whilst this might allow more income to be distributed, it may also have the effect of reducing capital.

You may request the sale of your shares on any Luxembourg business day.

The income received from the Fund's investments is accumulated with the result of increasing the value of the shares.

#### Terms to Understand

**Asset-backed securities:** Debt securities whose value and income payments are derived from a pool of underlying assets.

**Debt securities:** Securities representing the issuer's obligation to repay a loan at a specified date and to pay interest.

**Derivatives:** Financial instruments whose characteristics and value depend on the performance of one or more underlying assets, typically securities, indexes, currencies or interest rates.

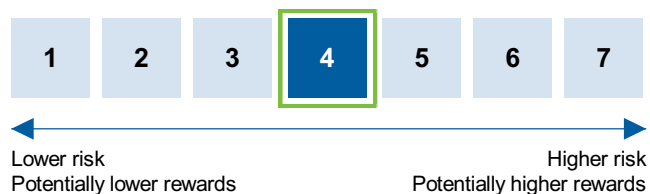
**Emerging markets:** Countries whose economy, stock market, political situation and regulatory framework are not fully developed.

**Hedging:** A strategy for totally or partially offsetting particular risks such as those arising from fluctuations in share prices, currencies or interest rates.

**Mortgage-backed securities:** Securities whose value and income payments are derived from the ownership of a pool of underlying mortgage debts.

**Securities in default:** Debt securities whose issuer condition has become uncertain and whose issuer is failing to make principal or interest payments when due.

#### Why is the Fund in this specific category?

The Fund invests mainly in debt securities of any quality from issuers of both developed and emerging countries. Such securities have historically been subject to price movements, generally due to interest rates, foreign exchange rates or movements in the bond market. As a result, the performance of the

Fund can fluctuate over time.

#### Risks materially relevant not adequately captured by the indicator:

**Credit risk:** the risk of loss arising from default that may occur if an issuer fails to make principal or interest payments when due. This risk is higher if the Fund holds low-rated, non-investment-grade securities.

**Derivatives risk:** the risk of loss in an instrument where a small change in the value of the underlying investment may have a larger impact on the value of such instrument. Derivatives may involve additional liquidity, credit and counterparty risks.

**Emerging markets risk:** the risk related to investing in countries that have less developed political, economic, legal and regulatory systems, and that may be impacted by political/economic instability, lack of liquidity or transparency, or safekeeping issues.

**Liquidity risk:** the risk that arises when adverse market conditions affect the ability to sell assets when necessary. Reduced liquidity may have a negative impact on the price of the assets.

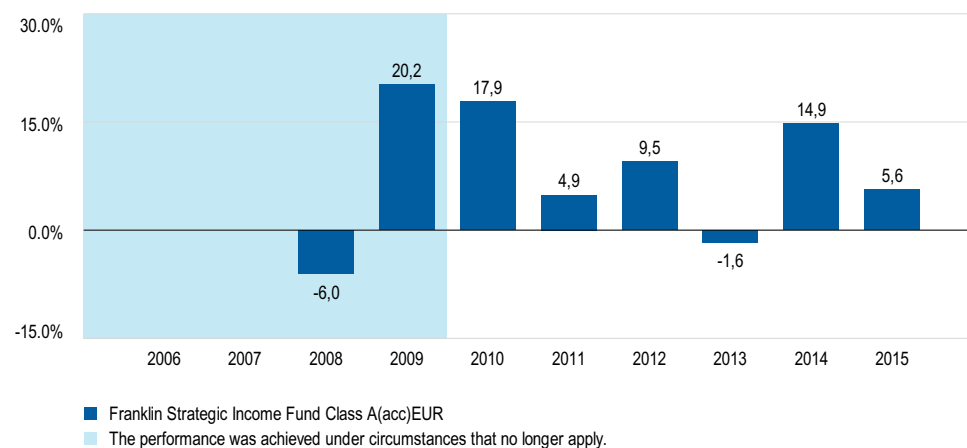
