What is this product?

Type

The product is a share class of FTGF Brandywine Global Fixed Income Fund (the "Fund") which is part of the Franklin Templeton Global Funds plc, an investment company with variable capital incorporated with limited liability in Ireland and established as an umbrella fund with segregated liability between sub-funds.

Term

The Fund has no maturity date. The Fund could be closed under the conditions laid down in the current prospectus of the Fund.

Objectives Investment Objective

The Fund's investment objective is to maximise total return consisting of income and capital appreciation.

Investment Policy

 The Fund will invest at all times at least 75% of its Net Asset Value in fixed income securities of countries that are represented within the FTSE World Government Bond Index (USD Hedged). The Fund may also invest in debt securities that are listed or traded on regulated markets located in other developed countries as set out in the Prospectus. The Fund seeks to achieve the investment objective by investing principally in debt securities issued or guaranteed by national governments, their agencies or instrumentalities and political sub-divisions and debt securities of supranational organisations.

· All debt securities purchased by the fund will be either rated investment grade or if unrated deemed by the investment manager to be of comparable quality at the time of purchase.

 The Fund may invest up to 25% of its Net Asset Value in debt securities of emerging market countries as defined by the JP Morgan GBI-EM Global Diversified Index.

• The Fund may invest in derivatives (financial instruments whose value is derived from the value of other assets), to help try to achieve the Fund's objective as well as to reduce risk or cost or to generate additional growth or income for the Fund.

This is an Article 8 fund under the EU Sustainable Finance Disclosure Regulation.

What are the risks and what could I get in return?

Risk Indicator





The actual risk can vary significantly if you cash in at an early stage and you may get back less.

· Manager's Discretion: The Fund is actively managed, and the investment manager has discretion in selecting investments within the Fund's objective and investment policies. The investment manager seeks to: (i) provide an annualized return for the Fund, on a gross basis over rolling 5-year periods, equal to the annualized return of the Benchmark plus 1.5% (gross of fees); and (ii) achieve an average weighted duration for the Fund's portfolio of between +/- 4 years of the effective duration of the portfolio of securities comprising the Benchmark. There is no guarantee that the investment manager will meet its targets (i.e. (i) and (ii) above), and (i) above does not take into account the fees charged, which will reduce the Fund's return.

Transaction Costs: The Fund bears costs in buying and selling investments, which may have a material impact on the Fund's performance. Share Class Policy

For this share class all, or some portion of, net income is declared and paid monthly to shareholders.

For this share class, in addition to net income being paid to investors as dividends, all or some portion of capital gains, and a portion of capital may be paid to investors as dividends. While this can increase the total dividends, it limits the potential for future capital growth.

For this share class, the manager applies a portfolio hedge that is intended to minimize the currency risk between the currency of the share class (which is in a non-base currency) and the base currency of the Fund.

Processing of subscription and redemption orders

You can buy, sell and switch your shares on each day that the New York Stock Exchange is open for business.

Intended retail Investor

The Fund may appeal to investors looking to maximise total return with a combination of income and capital appreciation by obtaining exposure to high quality global debt securities issued by governments or government related entities, as well as derivatives. Investors should be willing to hold their investment over the medium to long term for a minimum period of 3 to 5 years. The Fund is suitable for investors who do not need to have specific knowledge and/or experience of financial markets with the understanding that they may not get back the full amount invested in the Fund. Costs over Time
