What is this product?

Type

The product is a share class of FTGF ClearBridge US Equity Sustainability Leaders Fund (the "Fund") which is part of the Franklin Templeton Global Funds plc, an investment company with variable capital incorporated with limited liability in Ireland and established as an umbrella fund with segregated liability between sub-funds.

The Fund has no maturity date. The Fund could be closed under the conditions laid down in the current prospectus of the Fund.

Objectives

Investment Objective

The Fund's investment objective is to provide long-term capital appreciation. **Investment Policy**

- The Fund will invest at least 85% of its assets in shares of US companies that meet the investment manager's financial criteria and it's criteria for environmental, social and governance (ESG) policies.
- As an Article 8 fund under SFDR, the investment manager applies its ESG sustainability leader criteria to 100% of the portfolio of the Fund. The investment manager's portfolio construction process restricts the companies in the Fund's investable universe by at least 20% to accommodate only those companies that are sustainability leaders.
- The investment manager will try to focus on companies that, in their view, offer products and services that have a positive impact on society by doing less harm to people and the planet relative to other companies within the same industry.
- The Fund may invest in derivatives (financial instruments whose value is derived from the value of other assets), to help try to achieve the Fund's objective as well as to reduce risk or cost or to generate additional growth or income for the Fund.
- Benchmark: Russell 3000 Index
- Manager's Discretion: The Fund is actively managed. The investment manager has discretion in selecting investments within the Fund's objective

and investment policies. The benchmark is used for performance comparison purposes. While most of the Fund's securities will be components of the benchmark, the weightings of the holdings may differ materially from the weightings in the benchmark. The Fund may also invest in securities that are not included in the benchmark. The Fund's percentage exposures to sectors and industries may differ materially from those of the benchmark.

• Transaction Costs: The Fund bears costs in buying and selling investments, which may have a material impact on the Fund's performance. Share Class Policy

Income and gains from the Fund's investments are not paid but instead are reflected in the Fund's share price.

For this share class, the manager applies a portfolio hedge that is intended to minimize the currency risk between the currency of the share class (which is in a non-base currency) and the base currency of the Fund.

Processing of subscription and redemption orders

You can buy, sell and switch your shares on each day that the New York Stock Exchange is open for business.

Intended retail Investor

The Fund may appeal to investors looking to achieve capital appreciation by obtaining exposure to equity securities of US issuers that meet the investment managers ESG criteria and are deemed by the investment manager as sustainability leaders. Investors should be willing to hold their investment over the long term for a minimum period of 5 to 7 years. The Fund is suitable for investors who do not need to have specific knowledge and/or experience of financial markets with the understanding that they may not get back the full amount invested in the Fund.

What happens if Franklin Templeton International Services S.à r.l. is unable to pay out?

Franklin Templeton International Services S.à r.I. ("FTIS") is the management company of the Fund, but the assets are held separately from FTIS by the depositary. BNY Mellon SA/NV Dublin Branch, as the appointed depositary of the Fund, is liable to the Fund or its shareholders for any loss of financial instruments held in custody by it or its delegates (cash could however be lost in case of default of the depositary or its delegates).

What are the costs?

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs.
