What is this product?

Type

The product is a share class of FTGF ClearBridge Infrastructure Value Fund (the "Fund") which is part of the Franklin Templeton Global Funds plc, an investment company with variable capital incorporated with limited liability in Ireland and established as an umbrella fund with segregated liability between sub-funds.

Term

The Fund has no maturity date. The Fund could be closed under the conditions laid down in the current prospectus of the Fund.

Objectives Investment Objective

The Fund's investment objective is to achieve long-term stable growth comprised of regular and consistent income from dividends and interest, plus capital growth, from a portfolio of global infrastructure securities. **Investment Policy**

• The Fund will invest at least 80% of its net asset value in infrastructure companies via equity and equity-related securities listed or traded on regulated markets in the United States, United Kingdom, Japan, Germany, France, Italy and Canada, and equity and equity-related securities listed or traded on regulated markets of other developed countries and emerging market countries, including India ("OECD G7"). The Fund invests in a number of infrastructure sectors such utilities, transport, community and social infrastructure and communications.

• The Fund will typically be invested in 30 to 60 companies.

• The Fund may also invest in certain eligible China A-Shares via the Shanghai-Hong Kong Stock Connect and/or Shenzhen-Hong Kong Stock Connect.

• The Fund may invest in derivatives (financial instruments whose value is derived from the value of other assets), to help try to achieve the Fund's objective as well as to reduce risk or cost or to generate additional growth or income for the Fund.

This is an Article 8 fund under the EU Sustainable Finance Disclosure Regulation.

The investment manager uses the benchmark as its target return for the Fund – over the long term the investment manager seeks to provide an average annual return of the OECD G7 Inflation Index (which return will vary over time) plus 5.5%. There is no guarantee that the investment manager will meet its target, and the target does not take into account the fees charged, which will reduce the Fund's return. The benchmark does not constrain the investment manager's management of the Fund.

• Transaction Costs: The Fund bears costs in buying and selling investments, which may have a material impact on the Fund's performance. Share Class Policy

For this share class all, or some portion of, net income is declared and paid monthly to shareholders.

For this share class, in addition to net income being paid to investors as dividends, all or some portion of capital gains, and a portion of capital may be paid to investors as dividends. While this can increase the total dividends, it limits the potential for future capital growth.

For this share class, the manager applies a portfolio hedge that is intended to minimize the currency risk between the currency of the share class (which is in a non-base currency) and the base currency of the Fund.

You can buy, sell and switch your shares on each day that the New York Stock Exchange is open for business.

Intended retail Investor

The Fund may appeal to investors looking to achieve stable capital appreciation from regular and consistent income, interest and capital growth by obtaining exposure to global listed infrastructure equities of companies. Investors should be willing to hold their investment over the long term for a minimum period of 5 to 7 years. The Fund is suitable for investors who do not need to have specific knowledge and/or experience of financial markets with the understanding that they may not get back the full amount invested in the Fund.
