What is this product?

Type

The product is a share class of FTGF Western Asset Global Multi Strategy Fund (the "Fund") which is part of the Franklin Templeton Global Funds plc, an investment company with variable capital incorporated with limited liability in Ireland and established as an umbrella fund with segregated liability between sub-funds.

Term

The Fund has no maturity date. The Fund could be closed under the conditions laid down in the current prospectus of the Fund.

Objectives

Investment Objective

The Fund's investment objective is to maximise total return through income and capital appreciation.

Investment Policy

- The Fund will invest mostly in bonds issued by governments and corporations. The Fund may invest anywhere in the world, including developing countries.

- The Fund may invest in bonds rated investment grade at the time of purchase or, if not rated, deemed by the investment manager and sub-investment managers to be of comparable quality and lower rated bonds, with a minimum of 40% of the Fund's assets in higher rated bonds, and may be issued in various currencies.

- The Fund may invest in mortgage-backed and asset-backed securities, which are bonds that provide the bondholder with regular payments dependent on the cash-flow arising from a specified pool of assets such as interest and capital from mortgages or car loans. The Fund may purchase unsecured participations in or assignments of floating rate mortgages or other commercial loans that are liquid.

- The Fund may invest up to 10% in contingent convertible bonds (bonds that can convert into equity upon a specified event taking place).

- The Fund may invest in derivatives, financial instruments whose value is derived from the value of other assets, to help try to achieve the Fund's

objective as well as to reduce risk or cost or to generate additional growth or income for the Fund.

- This is an Article 8 fund under the EU Sustainable Finance Disclosure Regulation.

- Benchmark:** ICE BofA US Dollar 3-Month Deposit Offered Rate Constant Maturity Index

- Manager's Discretion:** The Fund is actively managed, and the investment manager is not constrained by the benchmark. The investment manager has discretion in selecting investments within the Fund's objective and investment policies. The benchmark is used for performance comparison purposes only.

- Transaction Costs:** The Fund bears costs in buying and selling investments, which may have a material impact on the Fund's performance.

Share Class Policy

For this share class all, or some portion of, net income is declared daily and paid monthly to shareholders.

Processing of subscription and redemption orders

You can buy, sell and switch your shares on each day that the New York Stock Exchange is open for business.

Intended retail Investor

The Fund may appeal to investors looking to maximise total return with a combination of income and capital appreciation by obtaining exposure to global debt securities of any quality denominated in any currency, as well as derivatives. Investors should be willing to hold their investment over the medium to long term for a minimum period of 3 to 5 years. The Fund is suitable for investors who do not need to have specific knowledge and/or experience of financial markets with the understanding that they may not get back the full amount invested in the Fund.

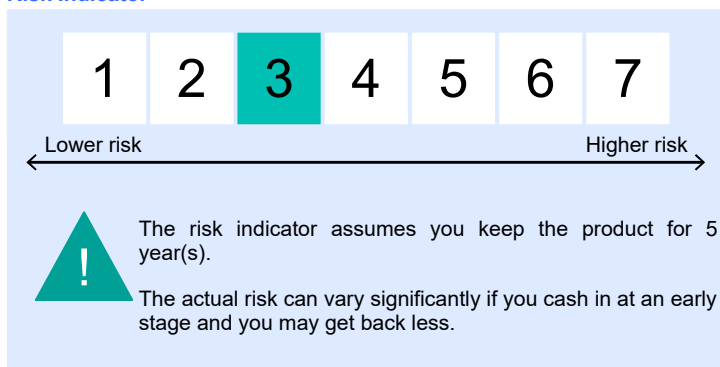

What are the risks and what could I get in return?

Risk Indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets.

What happens if Franklin Templeton International Services S.à r.l. is unable to pay out?

Franklin Templeton International Services S.à r.l. ("FTIS") is the management company of the Fund, but the assets are held separately from FTIS by the depository. BNY Mellon SA/NV Dublin Branch, as the appointed depository of the Fund, is liable to the Fund or its shareholders for any loss of financial instruments held in custody by it or its delegates (cash could however be lost in case of default of the depository or its delegates).

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario
