## What is this product?

### Type

The product is a unit of the sub-fund GAM Commodity (the sub-fund) of Multicooperation SICAV (the "Umbrella Fund"), a "société d'investissement à capital variable" (SICAV) and is authorised as an undertaking for collective investment in transferable securities (UCITS) in accordance with Part I of the Law of 17 December 2010 on undertakings for collective investment (the "Law of 2010").

### Term

The Fund has no maturity date. The Fund could be closed under the conditions set down in the current prospectus of the Fund.

### Objectives

#### Investment Objective

The aim of the sub-fund ("Fund") is to participate indirectly in the growth potential of the international commodity markets. The Fund strives to achieve higher capital growth over the long term than that of the benchmark index.

#### Investment Policy

The Fund invests at least 2/3 of its assets in a broadly diversified set of commodities or commodity classes using complex financial instruments. These complex financial instruments offer the same returns as the underlying commodities. As a result, there is no direct investment in physical commodities. The Fund may invest its assets in various currencies, the fluctuation in which is hedged against the base currency.

The obligations of the Fund arising out of its investments in complex financial instruments are covered by debt securities, money market instruments or cash. The debt securities are issued or guaranteed by governments or companies and offer a very high likelihood of being repaid on maturity.

The Fund may use complex financial instruments to hedge the Fund assets and to profit from promising investments.

The Fund follows a benchmark index Bloomberg Commodity Index on the basis of which the investment decisions are made. The Fund is actively

managed and, in order to achieve an excess return, overweights or underweights individual commodities or categories of commodity with respect to the benchmark index. Most commodities can be part of the benchmark index. The investment manager can, at its discretion and in accordance with the prospectus, also invest in commodities that are not included in the benchmark index in order to take advantage of specific investment opportunities.

#### Share Class Policy:

Any income arising from this Share Class will be accumulated. Other share classes of the Fund may distribute income.

The Fund has several share classes. These may differ with regard to fees, minimum investment, use of revenues and investor qualification.

#### Processing of subscription and redemption orders

Investors may buy or sell the Fund on any bank working day in Luxembourg.

### Intended retail Investor

This Fund is aimed at retail and professional clients and eligible counterparties, who are seeking capital accumulation across categories and have a medium-term investment horizon. This Fund is aimed at investors with basic knowledge or experience of financial products. The investor is prepared to bear financial losses and does not require any capital guarantees.

## What are the risks and what could I get in return?

The risk indicator assumes you keep the product for 5 years.

## What happens if Carne Global Fund Managers (Luxembourg) S.A. is unable to pay out?

### Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario
