## What is this product?

## Type

The Fund is a sub-fund of GAM Star Fund p.l.c., an open-ended investment company incorporated with limited liability under the laws of Ireland and authorised by the Central Bank of Ireland pursuant to the European Communities (Undertakings for Collective Investment in Transferable Securities) Regulations 1989 and is subject to the European Communities (Undertakings for Collective Investment in Transferable Securities) Regulations 2011, as amended.

## Term

The Fund has no maturity date. The Fund could be closed under the conditions set down in the current prospectus of the Fund.

## **Objectives**

#### Investment Objective

The investment objective of the Fund is to achieve capital appreciation.

#### **Investment Policy**

The Fund seeks to achieve this objective through investing primarily in quoted securities (e.g. shares) issued by companies with principal offices in the United States of America.

The fund manager adopts a disciplined, fundamental research process, consistently applied across cycles. There is no style or market cap bias.

The Fund is considered to be actively managed in reference to S&P 500 / Average 1 month deposit rate / Average 1 month deposit rate in class currency (the "Benchmarks") by virtue of the fact that it uses the Benchmarks in the appropriate currency for performance comparison purposes. However, the Benchmarks are not used to define the portfolio composition of the Fund and the Fund may be wholly invested in securities which are not constituents of the Benchmarks.

The fund manager has discretion in managing the investments of the Fund.

The Fund may use currency forwards for efficient portfolio management purposes. Further information on the Fund's use of currency forwards can be found under the Investment Objectives and Policies section within the Fund's Supplement. It is not the current intention that the Fund will use derivatives for investment purposes and in this way it is not intended that the Fund be leveraged to gain additional exposure.

#### Share Class Policy:

The Fund has several share classes. These may differ with regard to fees, minimum investment, currency, use of revenues and investor qualification.

Any income arising from this share class will be distributed. Other share classes of the Fund may accumulate income.

#### Processing of subscription and redemption orders

Investors may buy or sell the Fund daily (every Business Day of the Fund).

## Intended retail Investor

The Fund is aimed at retail clients, professional clients and eligible counterparties, who intend general capital formation and have a long-term investment horizon. This Fund may be for investors with basic knowledge or experience with financial products. The investor can bear financial losses and attaches no importance to capital guarantees.

# What are the risks and what could I get in return?

## **Risk Indicator**





The risk indicator assumes you keep the product for 7 years.

The actual risk can vary significantly if you cash in at an early stage and you may get back less.

# What are the costs?
