What is this product?

Type:

This product is UCITS fund.

Term:

This is an Open Ended Fund.

Objectives:

The Fund's investment objective is to provide investment results that, closely correspond, before fees and expenses to the performance of the Solactive China Biotech v2 USD Index Net Total Return (the "Index"). The Fund will aim to achieve its investment objective by attempting to replicate the performance of the Index by investing primarily in a portfolio of equity securities that as far as possible and practicable consists of the constituent stocks of the Index.

For Accumulating Shares, income will be automatically reinvested in the Fund and reflected in the NAV per share.

The Fund is open for subscriptions and redemptions on each Dealing

Day. Dealing day means a day on which the Hong Kong Stock Exchange is open for normal business or such Business Day(s) as the Directors may from time to time determine for dealings in the Fund (and notify in advance to Shareholders). The dealing cut-off time for the Fund is 4:00pm (Dublin time) on each business day prior to the relevant dealing day. Business day means a weekday other than the Friday before Easter, Christmas Day and New Year's day.

Intended retail investor:

This product is intended for investors who are prepared to take on a relatively high level of risk of loss to their original capital in order to get a higher potential return, and who plan to stay invested for at least 5 years. It is designed to form part of a portfolio of investments.

Risk Indicator
