Objectives and Investment Policy

Investment Objective:

The Fund aims to provide income by investing in a portfolio of Euro-denominated corporate bonds for a limited term, while promoting environmental, social and governance (ESG) characteristics.

The Fund promotes ESG characteristics within the meaning of Article 8 of SFDR. More information on HSBC Global Asset Management's responsible investing policies is available at www.assetmanagement.hsbc.com/about-us/responsible-investing. Investment Policy:

The Fund invests a minimum of 70% of its assets in Euro-denominated investment grade and non-investment grade bonds and other similar securities issued by companies in developed markets.

Certain ESG score criteria (ESG Criteria), which together with fundamental qualitative company analysis, are used to determine the Fund's investible universe Companies and/or issuers considered for inclusion within the Fund's portfolio will be subject to excluded activities in accordance with HSBC Asset Management's Responsible Investment Policies, which may change from time to time. Please refer to the Prospectus for more details on ESG Criteria and excluded activities

ESG Criteria, excluded activities and the need for enhanced due diligence will be identified and analysed using both HSBC's proprietary ESG Materiality Framework as well as research & information provided by financial and non-financial data providers. After identifying the investible universe, the Investment Adviser aims to construct a portfolio with a higher ESG score, calculated as a weighted average of the ESG scores of the Fund's investments against the weighted average ESG score of the issuers of the constituents of the reference benchmark.

The Fund is intended to be in operation until end of 30 September 2027 (the "Term Date"). On the Term Date, the Fund will be liquidated, and shares of the Fund will be compulsorily redeemed at the prevailing net asset valuation per share.

The Term Date may be deferred for up to 3 months if the Board of Directors believes it is in the best interest of shareholders.

The Fund will seek to invest in bonds with a final maturity date close to the Term Date, aiming to hold them to maturity whilst actively monitoring and maintaining the portfolio.

As the term date approaches, the Fund's assets will increasingly comprise of cash and money market instruments.


The Fund may invest up to 20% of its assets in non-investment grade rated bonds at the time of purchase.

The Fund may invest up to 10% of its assets in other funds, including HSBC funds and may also invest in bank deposits and money market instruments for treasury purposes. The Fund may hold shares (and securities similar to shares) received as a result of or in connection with a corporate action affecting existing portfolio holdings. The Fund's primary currency exposure is to the Euro.

The Fund may also invest in derivatives and use them for hedging and efficient portfolio management purpose. Derivatives will not be used extensively for investment

- purposes. Derivatives may also be embedded in other instruments used by the Fund. The Fund may enter into securities lending transactions for up to 29% of its assets. However, this is not expected to exceed 25%.
- The reference currency of the Fund is EUR. The reference currency of this share 4 class is EUR.
- The Fund is actively managed and does not track a benchmark. The reference benchmark for the Fund is 80% ICE BofA 1-5 year Euro Corporate Index (ER0V) 20% ICE BofA 0-5 year Euro Developed Markets High Yield (HEDC).
- The Investment Advisor will use its discretion to invest in securities not included in the reference benchmark based on active investment management strategies and specific investment opportunities. It is foreseen that the reference benchmark will not be used as a universe from which to select securities.
- Income is distributed.
- You may sell your investment on most working days.
- Recommendation: this Fund is not appropriate for investors who plan to withdraw their money before the Fund Term Date.

Why is this Fund in this specific category?

Material risks not fully captured by the Risk and Reward Indicator:

- Callable Bond Risk Any unexpected behaviour in interest rates could negatively impact the performance of callable debt securities (securities whose issuers have the right to pay off the security's principal before the maturity date).
- Counterparty Risk The possibility that the counterparty to a transaction may be unwilling or unable to meet its obligations.

- Credit Risk A bond or money market security could lose value if the issuer's financial health deteriorates.
- Default Risk The issuers of certain bonds could become unwilling or unable to make payments on their bonds.

The charges you pay are used to pay the running costs of the Fund, including the marketing and distribution costs. These charges reduce the potential growth of the investment.


