## **Objectives and Investment Policy**

#### Investment objective:

The Fund aims to make a positive environmental, social and governance (ESG) impact, by investing in shares and other similar securities issued by companies that actively contribute to United Nations Sustainable Development Goals (Contributing Companies and SDGs), while also aiming to provide long-term capital growth and income.

The Fund promotes ESG Characteristics within the meaning of Article 9 of SFDR. More information on HSBC Global Asset Management's responsible investing policies is available at

The SDGs that the Contributing Companies contribute to include, but are not limited to: Climate Action, Affordable and Clean Energy, Clean Water and Sanitation, Good Health and Well Being and Reduced Inequalities.

The Fund's investment principles, together with ESG impact analysis and fundamental qualitative company analysis are used to determine the Fund's investments and may include but are not limited to: continuous engagement with Contributing Companies regarding their ESG credentials; continuous engagement with companies regarding their ESG credentials at various stages of their ESG transition; companies following good ESG practices resulting in low and/or decreasing carbon intensity.

Companies and/or issuers considered for inclusion within the Fund's portfolio will be subject to excluded activities in accordance with HSBC Asset Management's Responsible Investment Policies, which may change from time to time. Please refer to the Prospectus for further details on Investment Principles and excluded activities. Investment principles, excluded activities and the need for enhanced due diligence may be identified and analysed using both HSBC's proprietary ESG Materiality Framework as well as research & information provided by financial and non-financial data providers. Investments in Chinese share markets include China A-shares and China B-shares with a maximum exposure of 20% of the Fund's assets. The

Fund may invest up to 10% of its assets in China A-shares through the Shanghai-Hong Kong Stock Connect and Shenzhen-Hong Kong Stock Connect. The Fund may invest up to 10% of its assets in China A-shares indirectly through China A-shares Access Products (CAAP) and may invest up to 10% of its assets in CAAPs issued by any single issuer. The Fund may invest up to 10% of its assets in Real Estate Investment Trusts, may invest in bank deposits and money market instruments for treasury purposes, and up to 10% in other funds (which will qualify under Article 9 of SFDR).

The Fund may invest in derivatives and use them for hedging, cashflow management and efficient portfolio management purposes. Derivatives may also be embedded in other instruments used by the Fund.

- The Fund may enter into securities lending transactions for up to 29% of its assets. However, this is not expected to exceed 25%.
- The reference currency of the Fund is USD. The reference currency of this share class is USD.
- The Fund is actively managed and does not track a benchmark. The reference benchmark for the Fund is MSCI AC World.
- The Investment Advisor will use its discretion to invest in securities not included in the reference benchmark based on active investment management strategies and specific investment opportunities. It is foreseen that a significant percentage of the Fund's investments will be components of the reference benchmark. However, their weightings may deviate materially from those of the reference benchmark.
- Income is distributed.
- You may sell your investment on most working days.
- Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within a period of 5 years.



#### Segregated liability

HSBC Global Investment Funds is an investment company ("Société d'Investissementà Capital Variable") with segregated liability between subfunds under Luxembourg law. This means that the holdings of one sub-fund are kept separate from the holdings of the other sub-funds and your investment in the Fund cannot be used to pay the liabilities of any other subfund.

The Fund is authorised in the Grand Duchy of Luxembourg and supervised by the Commission de Surveillance du Secteur Financier (CSSF). This key investor information is accurate as at 24 May 2024.
