

Objectives and Investment Policy

- ▶ The Fund aims to achieve a return on your investment, in US Dollar, through a combination of capital growth and income on the Fund's assets, which reflects the return of the MSCI World ex Switzerland Index (the Fund's benchmark index).
- ▶ The Fund aims to invest so far as possible and practicable in the equity securities (such as shares) that make up the benchmark index.
- ► The benchmark index is designed to provide representation of large and mid-cap segments of the equity markets in developed countries excluding Switzerland. The components of the benchmark index are weighted by market capitalisation. Market capitalisation, in this case, is the share price of the company multiplied by the number of shares readily available in the market.
- ► The Fund uses optimising techniques to achieve a similar return to its benchmark index. These may include the strategic selection of certain securities that make up the benchmark index or other equity securities not making up the benchmark which provide similar performance to certain constituent securities. These may also include the use of financial derivative instruments (FDIs) (i.e. investments the prices of which are based on one or more underlying assets).
- ► The Fund may also engage in short-term secured lending of its investments to certain eligible third parties to generate additional income to off-set the costs of the

Charges

The charges are used to pay the costs of running the Fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.


Past Performance
