Objectives

Investment Objective

The investment objective of JSS Sustainable Bond – Emerging Markets Local Currency (the "Sub-Fund") is to generate the highest possible income while maintaining balanced risk diversification and optimal liquidity.

Investment Policy

The assets of the Sub-Fund are invested worldwide in mainly fixed and variable-rate securities (including zero bonds) denominated in emerging markets currencies and issued or guaranteed by any type of issuer domiciled in emerging markets or by any type of issuer that conducts the majority of its economic activity in emerging markets.

The Sub-Fund may also invest in fixed or floating rate securities, including zero bonds that may have a non-investment grade rating. Non-investment grade rating means a credit rating that is lower than BBB- (Standard & Poor's, Fitch) or Baa3 (Moody's) or an equivalent quality rating. Furthermore, JSS Sustainable Bond – Emerging Markets Local Currency may invest its assets in distressed securities. Securities are considered as distressed if the following criteria are met: fixed income investments with a credit rating equal or lower than CC (Standard & Poor's, Fitch) or Ca
