## What is this product?

#### **Type**

This product is a fund. Classic Shares is a shareclass of the sub-fund Euro Bonds Defensive Responsible Investing, a sub-fund of the open-ended investment company governed by Belgian law, KBC Institutional Fund. This open-ended investment company does fulfil the requirements of the UCITS Directive. (\*)

#### Term

Unlimited

#### **Objectives**

KBC Institutional Fund Euro Bonds Defensive Responsible Investing aims to generate a return by investing chiefly in government bonds denominated in euros. All regions and sectors may be taken into consideration.

The fund invest in bonds with a minimum credit rating\* of AA-/Aa3 from Standard & Poor's, Moody's or Fitch, and/or in government bonds issued in local currency that do not have a rating from the above rating agencies but of which the issuer has been assigned a AA-/Aa3 rating by at least one of the above rating agencies. All maturities are taken into consideration when selecting the bonds and debt instruments.

The fund invests only in bonds issued or guaranteed by governments or government institutions.

The fund can invest up to 100% of its assets in securities or money market instruments\* issued or guaranteed by a Member State of the euro area, provided the state concerned meets the above credit rating.

Within the limitations described above, the fund pursues responsible investing objectives based on a dualistic approach: a negative screening and a positive selection methodology.

The negative screening entails that the fund may not invest in assets of issuers that are excluded based on exclusion criteria (including tobacco, gambling activities and weapons). The positive selection methodology is a combination of portfolio targets and supporting sustainable development.

Portfolio targets are based on a reduction in greenhouse gas intensity and an improvement in ESG characteristics versus its reference portfolio.

Sustainable development is supported by investing in bonds that finance green and/or social projects and in governments, supranational debtors and/or agencies linked to governments that contribute to the achievement of the UN Sustainable Development Goals.

KBC Institutional Fund Euro Bonds Defensive Responsible Investing is actively managed with reference to the following benchmark: JP Morgan EMU ex Portugal, Ireland, Italy, Greece and Spain all Maturities - Total Return Index.

However, is not the aim of the fund to replicate the benchmark. The composition of the benchmark is taken into account when compiling the portfolio.

In line with its investment policy, the fund may not invest in all the instruments included in the benchmark.

When compiling the portfolio, the manager may also decide to invest in instruments that are not included in the benchmark, or indeed not to invest in instruments that are included.

Due to the aforementioned responsible investing methodology, the composition of the portfolio will differ from that of the benchmark.

The benchmark is also used to determine the fund's risk limitation mechanism. This limits the extent to which the fund's return may deviate from the benchmark.

The longterm expected tracking error for this fund is 0.75%. The tracking error measures the volatility of the fund's return relative to that of the benchmark. The higher the tracking error, the more the fund's return fluctuates relative to the benchmark. Market conditions may cause the actual tracking error to differ from the expected tracking error.

KBC Institutional Fund Euro Bonds Defensive Responsible Investing may make limited use of derivatives\*. This means that derivatives can be used either to help achieve the investment objectives (for instance, to increase or decrease the exposure to one or more market segments in line with the investment strategy), or to neutralise the portfolio's sensitivity to market factors (by hedging an exchange rate risk, for example).

The fund is denominated in Euro.

The fund reinvests any income received in the manner set out in the prospectus (for more details, see section 'Types of units and fees and charges' of the information for this sub-fund in the prospectus).

Each sub-fund of KBC Institutional Fund should be considered as a separate entity. Your rights as an investor are restricted to the assets of the sub-fund. The obligations of each individual sub-fund are covered only by the assets of that sub-fund.

#### Intended retail investor

The product is aimed at retail investors who want to build up wealth and have an investment horizon of around 3 years.

These investors are willing to take a certain amount of risk for a potentially higher return and can bear losses under adverse conditions.

These investors have at least a basic knowledge of and/or experience with investing.

## What are the risks and what could I get in return?

#### Risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 3 out of 7, which is a medium-low risk class.

3 is typical for bond funds, which tend to have an indicator of 2 or 3. Bond funds are generally less sensitive to the markets than equity funds, which tend to have an indicator of 4 or even 5 in some cases. The value of bond funds is especially sensitive to changes in interest rates, since the interest on these bonds is fixed in advance and does not go up when market rates increase. If rates go up, the value of the bonds already in the fund will fall.

This product does not include any protection from future market performance so you could lose some or all of your investment.

If we are not able to pay you what is owed, you could lose your entire investment.

Moreover, an investment in this fund involves:

- a moderate level of inflation risk: there is no protection against an increase of the inflation. There is no capital protection.

#### **Scenarios**

The figures shown include all the costs of the product itself, but may not include all the costs that you pay to your advisor or distributor. The figures do not take into account your personal tax situation, which may also affect how much you get back.

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted. The unfavourable, moderate, and favourable scenarios shown are illustrations using the worst, average, and best performance of the product over the last 10 years. ## What happens if KBC Asset Management NV is unable to pay out?

Because you invest directly in the fund, the failure of the Management Company, KBC Asset Management NV, to make distributions (for example, due to insolvency) would have no direct consequences on the ability of the fund to make distributions.

In the event that the fund itself fails to make distributions, you may lose your investment entirely. The fund is not covered by any compensation, guarantee scheme or any other form of investor guarantee.

#### What are the costs?

#### Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest and how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

- in the first year you would get back the amount you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario
- 10 000 EUR is invested.

## How long should I hold it and can I take my money out early?

#### Recommended holding period: 3 years

Given the investment strategy of this product, we recommend holding on to this product for 3 years or longer. The holding period is determined with the aims to reduce the timing risk when entering and exiting the product, and to ensure sufficient time for the underlying assets to recover in case of unfavourable market conditions. According to our estimates, the probability of getting a positive return is higher when you hold on to the recommended holding period or longer. You can exit this product before the recommended holding period, but in that case the probability of getting less back than the initial investment is higher.

A partial or full exit is free of charge. However, if you exit within one month after the entry, the fee mentioned in the 'What are the costs?' section can be charged.
