What is this product?

This investment fund is a sub-Fund of Legal & General UCITS ETF Plc (the "Company"), an umbrella investment company with variable capital Type: and segregated liability between Funds. The Fund is authorised in Ireland and regulated by the Central Bank of Ireland.


Term:

The Fund is a passively managed exchange traded Fund that aims to track the performance of the Solactive EPIC Optical Technology & Photonics Index NTR (the "Index"), subject to the deduction of the ongoing charges and other costs associated with operating the Fund.The Fund promotes a range of environmental and social characteristics which are met by tracking the Index. Shares in this Share Class (the "Shares") are denominated in USD and can be bought and sold on stock exchanges by ordinary investors using an intermediary (e.g. a stockbroker). In normal circumstances, only Authorised Participants may buy and sell Shares directly with the Company. Authorised Participants may redeem their Shares on demand in accordance with the "Dealing Timetable" published on http://www.lgim.com.The Index is designed to provide exposure to equity securities of global companies that are actively engaged in the optical technology and photonics value-chain. The Index will exclude companies which are constituents of the "ESG Exclusions Enhanced Index", including, but not limited to, companies which (i) are non-compliant with the UN Global Compact, as well as companies which derive a certain percentage of revenue as a result of (ii) direct involvement, or indirect involvement through corporate ownership, in controversial weapons, (iii) involvement in military contracting weapons or related products, (iv) involvement in the production or retail of tobacco, or otherwise are a related product/service, and/or (v) involvement in the generation, production or increase the capacity of conventional oil and gas, or otherwise involved in supporting products/services. Such exclusions are determined by reference to the Index Methodology available at https://www. Solactive.com/indices/?se=1&index=DE000SL0E2G2. The Fund will primarily invest directly in the securities represented in the Index in similar proportions to their weightings in the Index. The Fund may also invest in (1) companies that are not constituents of the Index that have similar risk and performance characteristics to the companies contained in the Index and (2) financial derivative instruments (i.e. investments the prices of which are based on the companies contained in the Index and/or such other companies). Adjustments to the Fund's portfolio, including as a result of a reconstitution of the Index, will incur transaction costs. This Share Class does not intend to pay dividends. Any income which may result from the Fund's investments will be reinvested into the Fund. The depositary of the Fund is the Bank of New York Mellon SA/NV, Dublin Branch. Intended

The Fund is designed for investors looking to grow their money in an investment which can form part of their existing savings portfolio. retail investor: Although investors can take their money out at any time, the Fund may not be appropriate for those who plan to withdraw their money within five years. The Fund is not designed for investors who cannot afford more than a minimal loss of their investment.

What is the risk and what could I get in return?

What are the costs?
