Lazard Emerging Markets Equity Advantage Fund is a sub-fund of Lazard Global Active Funds Public Limited Company (the "UCITS")

Objectives and Investment Policy

Lazard Emerging Markets Equity Advantage Fund (the "Fund") aims to achieve long-term capital appreciation.

The Fund is actively managed and will seek to achieve its objective primarily by investing in the equity and equity related securities (i.e. shares including exchange traded and over the counter common and preferred stocks, ADRs, GDRs, EDRs, REITs (real estate investment trusts), warrants and rights) of companies that are domiciled, incorporated, listed or derive 50% or more of their net assets and/or revenues from Emerging Market countries

The Investment Manager will use a systematic bottom-up stock selection process. The broad universe of emerging markets stocks will be screened (according to a series of customized measures designed by the Investment Manager and implemented through several proprietary quantitatively-based computer models) for minimum capitalization, data availability and liquidity characteristics in order to arrive at an investible universe of approximately 1,800 emerging market stocks. Each company is then assessed daily in terms of its growth, valuation, market sentiment, and financial quality.

Up to 10% of the Fund's net assets may be held in cash and in investments that are deemed to be equivalent to cash. This percentage may be exceeded where deemed appropriate by the Investment Manager in light of market conditions and the best interests of Shareholders.

Investment in securities listed or traded in Russia will not exceed 20% of the value of the Fund at any time and shall be limited to investments traded on the Moscow Exchange.

The Fund may also invest up to 10% of its value in units or shares of other investment funds (including exchange traded funds and other sub-funds of the UCITS).

The Fund may use derivatives (which are financial contracts whose value is linked to the price of an underlying investment) for the purposes of efficient portfolio management.

You can buy and sell shares in the Fund on any day on which the stock exchanges in London and New York are open for business.

The Fund has discretion as to which investments it will hold within the limits of the Investment Objective and Policy.

Income and profits, if any, attributable to your shares will not be paid out as a dividend but will be accumulated in the Fund on your behalf and reflected in an increase in the value of your holdings.

The Fund's performance is measured against the performance of the MSCI Emerging Markets Index (the "Benchmark"), which the Investment Manager has assessed to be the most appropriate Benchmark for measuring performance. The performance of the Fund seeks to exceed the Benchmark performance. The Fund is not constrained by the Benchmark as it has flexibility to invest in securities and asset classes not included in the Reportmark

The Fund promotes environmental and/or social characteristics within the meaning of Article 8 of Regulation (EU) 2019/2088, the "SFDR Regulation".

Recommendation: This Fund may not be appropriate for investors who plan to withdraw their money within a short period of time.

The risk rating of this share class is calculated on the basis of historic volatility – i.e. how much the value of the underlying assets of the Fund has fluctuated over the last 5 years. As this share class does not have 5 years' performance data available, we have simulated the volatility, using a suitable proxy, based on historic data.

This share class has been placed in the risk category stated above, because based on the simulated historic data, the underlying assets within the Fund have shown high volatility.

Please note, there are other risks that may not be reflected in the risk and reward categories above. Some of these risks are summarised below.

- This Fund may invest in the securities of emerging markets. These markets may be
 less developed than others and so there is a greater risk that the Fund may experience
 greater volatility, delays in buying, selling and claiming ownership of its investments.
 Emerging markets may also have less developed political, economic and legal systems
 and there is a higher risk that the Fund may not get back its money.
- The Fund may invest in units or shares of other investment funds. Such other funds may themselves be subject to their own fees and expenses.
- There is a risk that the other side to certain contracts that the Fund may enter into may
 not be able to meet obligations. For example, this may arise in the Fund where an
 investment is made using a derivative, and the other side to the derivative contract
 becomes insolvent, or is otherwise unable to meet its obligations. In such a case, the
 Fund may incur loss.


