You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

- **Type:** The product is a Sub-fund of Mediolanum Best Brands (the Fund), an open-ended umbrella Unit Trust established by Mediolanum International Funds Limited as a UCITS pursuant to the provisions of the UCITS Regulations and governed by Irish law.
- **Term:** This is an open ended fund with no maturity date.
- **Objectives:**
 - The Sub-Fund's objective is to achieve long term capital growth.
 - The Sub-Fund invests primarily in European (including emerging market) equities (listed shares) and equity related securities either directly and/or indirectly (by investing in funds and/or derivatives).
 - The Sub-Fund invests mainly in funds which are selected following Manager evaluation of: investment team strength, underlying investment process quality and opportunity for future capital growth.
 - The Sub-Fund may use financial derivative instruments (FDIs) whose performance is linked to that of underlying security(s) or asset class(es). Their use may be for efficient portfolio management, hedging and/or direct investment purposes.
 - The Sub-Fund may enter into securities lending transactions.
 - The Sub-Fund is actively managed (meaning that the Manager has full discretion over the composition of the Sub-Fund's portfolio of assets) and is not managed with reference to any benchmark.
 - The Manager has flexibility to change the Sub-Fund's asset allocation (% of the portfolio invested in equities/FDIs etc) at any time and has discretion to select investments within each asset class.
 - The product is compatible with investors that can bear and/or afford to fully or partially lose the capital invested and are comfortable with no capital guarantee.
 - FDIs are used to remove the impact of exchange rate movement (hedging) which may affect the value of this Class of Unit.
 - Income and gains generated by the unit class will be reinvested. No dividend will be paid.
 - Units can be bought or sold on any business day from the Fund's Administrator.

- **Intended retail investor:** This investment product has been developed for distribution in Europe and intended for retail investors (including those with a basic knowledge of financial instruments) who can accept the risk noted in the Risk Indicator section.

What are the risks and what could I get in return?



The risk indicator assumes you keep the product for 10 years.

- The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.
- We have classified this product as 4 out of 7, which is a medium risk class.
- This rates the potential losses from future performance at a medium level, and poor market conditions are very unlikely to impact the capacity of the issuer to pay you.
- This product does not include any protection from future market performance so you could lose some or all of your investment.

What happens if Mediolanum International Funds Limited is unable to pay out?

The assets of the Fund are held in safekeeping by its depositary. In the event of the Manager's insolvency, the Fund's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss. In such a scenario, there is no investor guarantee scheme and you could lose all of your investment.

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. - In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

How long should I hold it and can I take money out early?

Recommended holding period: 10 years

The recommended holding period for this Sub-Fund is determined based on the risk of the investment and the characteristics of the contract. The investor has the right to totally or partially redeem the contract on any valuation day, collecting the redemption value calculated based on the value of the shares of the Sub-Fund on the date the request is received by the Manager, without any redemption fee being applied. We recommend that you hold the investment at least until the end of the recommended holding period in order to fulfil the objectives of this product. This product may not be suitable for investors who plan to redeem their contract before the end of the recommended holding period. The product does not provide any guarantee of return on the expiration of the recommended time horizon, and any redemption before that date may compromise the investment performance.
