You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

- Type: The product is a Sub-fund of Mediolanum Best Brands (the Fund), an open-ended umbrella Unit Trust established by Mediolanum International Funds Limited as a UCITS pursuant to the provisions of the UCITS Regulations and governed by Irish law.
- Term: This is an open ended fund with no maturity date.
- · Objectives:
 - The Sub-Fund's objective is to pay regular dividends and achieve medium-long term capital growth.
 - The Sub-Fund invests in global (including emerging market) fixed income securities (such as bonds issued by companies or governments), equities (listed shares), equity related securities and commodities (marketable goods such as copper and oil) either directly and/or indirectly (by investing in funds and/or derivatives).
 - The Sub-Fund aims to use a risk-parity approach to asset allocation (balancing risk allocation across different asset types) and to maintain a medium level of volatility (a measure of risk in a financial security).
 - The Sub-Fund invests in Invesco range funds which are selected following Manager evaluation of: investment team strength, underlying investment process quality, opportunity for future capital growth and ability to pay dividends.
 - The fixed income securities invested in may be rated investment grade (by a generally recognised international rating agency), below investment grade or unrated.
 - The Sub-Fund may use financial derivative instruments (FDIs) whose performance is linked to that of underlying security(s) or asset class(es). Their use may be for efficient portfolio management, hedging and/or direct Investment purposes.
 - The Sub-Fund may enter into securities lending transactions.
 - The Sub-Fund is actively managed (meaning that the Manager has full discretion over the composition of the Sub-Fund's portfolio of assets) and is not managed with reference to any benchmark.
 - The Manager has flexibility to change the Sub-Fund's asset allocation (% of the portfolio invested in equities/bonds/FDIs etc) at any time and has discretion to select investments within each asset class.
 - The product is compatible with investors that can bear and/or afford to fully or partially lose the capital invested and are comfortable with no capital guarantee.
 - Income and gains generated by the unit class will be distributed periodically in the form of a dividend.
 - Units can be bought or sold on any business day from the Fund's Administrator.

What are the risks and what could I get in return?

How long should I hold it and can I take money out early?

Recommended holding period: 7 years

The recommended holding period for this Sub-Fund is determined based on the risk of the investment and the characteristics of the contract. The recommended holding period specified above takes into account the investment option featured in the product with the longest holding period. The investor has the right to totally or partially redeem the contract on any valuation day, collecting the redemption value calculated based on the value of the shares of the Sub-Fund on the date the request is received by the Manager, without any redemption fee being applied. We recommend that you hold the investment at least until the end of the recommended holding period in order to fulfil the objectives of this product. This product may not be suitable for investors who plan to redeem their contract before the end of the recommended holding period.
