What is this product?

Type

This product is a UCITS Investment Fund.

Term

This product has no fixed end date. However the Sub-Fund, at its absolute discretion, can redeem all the shares of the Sub-Fund under the circumstances set out in the prospectus.

Objectives

Investment objective The investment objective of the Sub-Fund is to achieve attractive risk-adjusted returns.

Investment policies The Sub-Fund will seek to achieve its objective by primarily investing in a diversified portfolio of investment grade fixed and floating rate government and corporate debt securities of varying maturities, including bonds, which are predominantly listed or traded on recognised markets and are denominated in major world currencies. Debt securities are securities which represent an obligation of the entity issuing the security to repay the amount received for the security plus interest. The interest rates paid may be variable or fixed and payment may be deferred or paid in kind.

The Sub-Fund is actively managed and will seek to outperform the JP Morgan GBI Global 1-3 Year Total Return Index (Hedged) (the "Index") by 0.5% - 1.0%, gross of the fees of the Manager, the Investment Manager and the Distributor, but net of all other fees and expenses of the Sub-Fund, on average per annum over the medium to long term. The Investment Manager may use its discretion to invest in, for example, securities, issuers, companies or sectors not included in the Index.

The Index captures fixed-rate, local currency treasury bonds, with minimum term to maturity greater than or equal to one year and less than three years, issued by developed markets. There is no guarantee the Sub-Fund will outperform the Index.

The Sub-Fund is anticipated to have a tracking error within a range of 1.0% - 3.0% on an ex-post basis, although this is not a target or a restriction and there is no guarantee the Sub-Fund will stay within this range. Tracking error is an indicator of the degree to which the Sub-Fund's performance may deviate from that of the Index. Certain indices (including the Index) may also be used in the management of the Sub-Fund, including for investment purposes, as detailed in the supplement.

The Sub-Fund promotes environmental and social characteristics within the meaning of Article 8 of the Sustainable Finance Disclosure Regulation ("SFDR").

The Sub-Fund will promote environmental characteristics by seeking to mitigate the impact of climate change through reducing the potential carbon footprint of the Sub-Fund. The Sub-Fund will seek to avoid exposure to companies that are deemed by the Investment Manager and its delegates as the worst carbon emitters with the lowest carbon transition potential, being companies whose carbon emissions intensity exceed 3,000 tonnes CO₂ equivalent per \$1million revenue, or those companies that generate more than 1% of revenue from thermal coal extraction, arctic drilling, or oil tar sand mining.

The Sub-Fund promotes social characteristics by avoiding investment in companies that are involved in the manufacture, distribution or sales of controversial weapons, or which manufacture tobacco products or generate more than 50% of their revenue from tobacco distribution or sales. The Sub-Fund also avoids investing in companies with material exposure to negative environmental impact, violation of international law/human rights, corruption and economic crime, recreational cannabis and production of coal or coal-related products.

Further, the Sub-Fund will invest at least 25% in sustainable investments, being investments which, according to the Investment Manager's framework: (a) contribute positively to UN Sustainable Development Goals; (b) do no significant harm to any environmental or social objective; and (c) follow good governance practices.

The Sub-Fund may invest no more than 20% in fixed income securities which are rated below investment grade but which are at least rated speculative grade (which means a minimum credit rating of B-/B3). Up to 50% can be invested in emerging markets. The Sub-Fund may use financial derivative instruments (instruments for which the price is dependent on one or more underlying asset, "FDI") for hedging, efficient portfolio management and/or investment purposes. FDI may enable the Sub-Fund to obtain market exposure in excess of the value of the Sub-Fund's assets. The level of leverage for the Sub-Fund is expected to range from 0% to 200% of net asset value, although investors should note that higher levels of leverage may be experienced.

Your shares will be hedged with the aim of mitigating the effect of exchange rate fluctuations between the currency of your share class and the Sub-Fund's base currency. The currency hedging approach may not be successful, so changes in exchange rates may adversely impact the value of your investment.

Redemption and Dealing You can buy and sell shares in the Sub-Fund on demand each day which is a bank business day in Ireland or the United Kingdom ("Dealing Day").

Distribution Policy The Share Class will not distribute dividends. Income and capital gains from the Sub-Fund are reinvested.

Intended retail investor

Investors who have at least a basic understanding of financial markets and the underlying investment instruments, who understand the risk of the Sub-Fund including the risk of capital loss and that the product should not constitute a complete investment plan and:

- have a long term investment horizon
- seek a product which promotes environmental and/or social characteristics

Practical information

Depository The Sub-Fund's assets are held through its depository, State Street Custodial Services (Ireland) Limited.

Further information This document describes a Share Class of the Sub-Fund, which is a sub-fund of MGI Funds plc constituted as an umbrella, comprising a number of sub-funds (including the Sub-Fund), each having a separate portfolio of assets. As a matter of Irish law, the

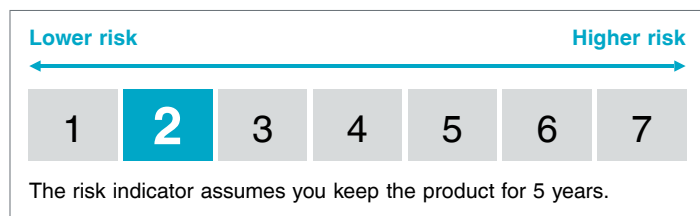
assets of one sub-fund will not be available to meet the liabilities of another. However, MGI Funds plc is a single legal entity that may operate, have assets held on its behalf, or be subject to claims in other jurisdictions that may not necessarily recognise such segregation. Accordingly, there is no absolute certainty that the assets of a sub-fund will not be exposed to the liabilities of other sub-funds of MGI Funds plc. Investors do not have the right to exchange shares in one sub-fund for

What are the risks and what could I get in return?

Risk Indicator

What happens if Mercer Global Investments Management Limited is unable to pay out?

The Sub-Fund is responsible for paying redemptions and any other payment obligations due to investors. The Manager is not responsible for meeting the obligations of the Sub-Fund to investors from its own assets. The Sub-Fund's assets are safeguarded by the Depositary in accordance with applicable law. If the Sub-Fund is unable to pay out to investors due to its insolvency, investors will be unsecured creditors in the insolvency process and are likely to suffer a financial loss. Investors may also suffer a financial loss in the event of the Depositary's insolvency or default (or that of any custody delegate). Investors in UCITS, such as the Sub-Fund, are not covered under the terms of the Irish statutory investor compensation scheme.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest and how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- in the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario,
- 10,000 EUR is invested.

How long should I hold it and can I take money out early?

Recommended holding period: 5 years

This product is designed for long term investment; you should be prepared to stay invested for at least 5 years. However, you can redeem your investment without penalty at any time during this period, or hold the investment longer. Redemptions are possible on any Dealing Day provided written instruction is received by the Administrator before 1pm (Irish time). It will typically take 3 Business Days for you to be paid.
