## What is this product?

### TYPE OF PRODUCT

The product is a sub-fund of MFM Funds (Lux), an Undertaking for Collective Investment in Transferable Securities (UCITS) incorporated as a variable capital investment company (SICAV) under the laws of Luxembourg.

The Sub-Fund is established for an unlimited duration. However, the Directors may decide to close this product under certain circumstances.

#### **OBJECTIVES**

### Objectives and investment policy

The Sub-Fund has a sustainable investment objective. The investment manager applies sustainability criteria when selecting investments for the Sub-Fund. The Sub-Fund invests 100% of its net assets (excluding investments in undertakings for collective investment (UCIs) and cash) in global green, social and sustainability bonds. They are designed to provide direct and measurable exposure to activities that benefit environmental and social welfare.

The Sub-Fund will mainly invest debt securities of any type (including money market instruments) which comply with the following:

- they are issued or guaranteed by sovereign, private and public issuers, and
- are defined as "green bonds", "social bonds" or "sustainable bonds".
- Debt securities all of the proceeds of which are used to finance or refinance new or existing projects which will have
- a positive environmental impact, are "Green bonds";
- a positive social impact, are "Social bonds".

"Sustainable bonds" are debt securities all of the proceeds of which are used to finance a combination of above-mentioned both green and social projects.

The choice of investments will neither be limited by geographical area and/or economic sector nor in terms of currencies in which investments will be denominated. However, depending on financial market conditions, a particular focus can be placed on a single country (or some countries), a single currency, and/or a single economic sector.

On an ancillary basis, the Sub-Fund may invest in any other type of eligible asset, such as structured products, and undertakings for collective investment (UCIs). The Sub-Fund may invest a substantial part of its net assets in emerging markets. However, in normal market conditions, such investments should not exceed 50% of its net assets.

The Sub-Fund can be exposed to investment grade and non-investment grade debt securities.

This Sub-Fund will invest a maximum of:

- 10% of its net assets in units or shares of UCIs.
- 50% of its net assets in non-investment grade debt securities (or issuers).
- 10% of its net assets in distressed or defaulted debt securities (or issuers).
- 10% of its net assets in contingent convertible debt securities.
- 10% of its net assets in structured.

If the Investment Manager considers this to be in the best interest of the Shareholders, on a temporary basis and for defensive purposes, the Sub-Fund may also hold, up to 100% of its net assets, term deposits, money market UCIs (within the 10% above-mentioned limit) and money market instruments.

**Derivatives** For hedging and for any other purposes, the Sub-Fund may use all types of financial derivative instruments traded on a regulated market and/or over the counter. However, the investment manager should principally use options, futures and currency derivatives.

Benchmark The Sub-Fund is actively managed. The Sub-Fund has no benchmark index and is not managed in reference to a benchmark index.

**Dividend Policy** This Class is cumulative. Dividend distributions are not planned.

Share Class Currency The currency of the Class is EUR.

The recommended holding period of this product is determined to allow sufficient time for this product to reach its objectives and avoiding short term market fluctuations.

The return of the product is determined using the Net Asset Value (the "NAV") calculated by FundPartner Solutions (Europe) S.A. (the "Administrative Agent"). This return depends mainly on the market value fluctuations of the underlying investments.

### INTENDED RETAIL INVESTORS

The product is only available to investors approved by the Board of Directors who subscribe to this class within the initial subscription period of the Sub-Fund. This Class will be closed to subscriptions once the assets of this Class will reach EUR 20 000 000. This Class will not be closed to subscriptions before 30 June 2019 but will be closed at the latest on 31 December 2019. The product is compatible with investors who may bear capital losses and who do not need capital guarantee. The product is compatible with clients looking for growing their capital and who wish to hold their investment over 5 years.

**Asset segregation** The assets and liabilities of each sub-fund are segregated by law, which means that the performance of the assets in other sub-funds does not influence the performance of your investment.

**Dealing** The NAV for the Class is calculated on each bank business day in Luxembourg (the "Calculation Day"), on the basis of the prices as of the preceding business day (the "Valuation Day"). The cut-off time to submit subscriptions/redemptions orders is 12 noon Luxembourg time on the bank business day preceding the Valuation Day.

**Switching** Shareholders may apply for any share of any sub-fund to be converted into shares of another sub-fund, provided that the conditions for accessing the target class, type or sub-type, are fulfilled with respect to the Sub-Fund, on the basis of their respective NAV calculated on the Valuation Day following receipt of the conversion request. The redemption and subscription costs connected with the conversion may be charged to the shareholder as indicated in the prospectus. ### What happens if FundPartner Solutions (Europe) S.A. is unable to pay out?

The Management Company is not making any payment to you in relation to the Sub-Fund and you would still be paid in case of a default from the Management Company.

The Sub-Fund's assets are held with a separate company, the Depositary, so the Sub-Fund's ability to pay out would not be affected by the insolvency of the Management Company. However, in the event of the Depositary's insolvency, or its delegates, the Sub-Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Sub-Fund. The Depositary will also be liable to the Sub-Fund or its investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfill its obligations (subject to certain limitations).

If the Sub-Fund is terminated or wound up, the assets will be liquidated and you will receive an appropriate share of any proceeds but you may lose part or all of your investment.

There is no compensation or guarantee scheme protecting you from a default of the Depositary.

### What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

#### **Costs over time**

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.
