Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

US High Yield Bond Fund (the 'Fund')

a sub-fund of Nomura Funds Ireland plc (the "Company")

Class AD USD (IE00BWXC8F79)

This product is manufactured by Bridge Fund Management Ltd. The Fund is authorised in Ireland and is approved as an Undertaking for Collective Investment in Transferable Securities ("UCITS") by the Central Bank of Ireland. What is this product?

Type

Class AD USD is a share class of the Fund, a sub-fund of the Company, which is an Irish UCITS variable capital umbrella investment company with segregated liability between sub-funds authorised by the Central Bank of Ireland.

Term

This product has no fixed term. The product may be liquidated under limited circumstances as detailed in the prospectus.

Objectives

Any income generated by the fund will be paid to you or can be reinvested in additional shares to grow the value of your investment.

The Fund aims to achieve income and capital growth by investing primarily in bonds (which are like loans that can pay a fixed or variable rate interest rate) issued mainly by companies in the US and Canada.

The Fund shall invest primarily in U.S. Dollar denominated debt and debt-related securities issued principally by entities in the United States including corporations, limited liability companies or limited partnerships and other forms of enterprise and in sovereign, quasi-sovereign and supranational debt and debt-related securities. The Fund will normally invest at least 80% of its value in bonds that have ratings lower than investment grade, as

defined by international agencies that provide such ratings; these may offer a higher income but also carry greater risk. Up to 25% of the value of the Fund may be invested outside the US and Canada.

The Fund is considered to be actively managed in reference to the index (ICE Bank of America Merrill Lynch US High Yield Constrained Index) by virtue of the fact that it uses the index for performance comparison purposes. Certain of the Fund's securities may be components of and may have similar weightings to the index. However, the Fund may deviate significantly from the index and the investment manager may use its discretion to invest in companies or sectors not included in the index.

Intended retail investor

The Fund is intended for retail and institutional investors. The Fund may not be appropriate for investors who plan to withdraw their money within 5 years.

The Fund is suitable for investors seeking long-term income and capital growth and who are prepared to accept a moderate level of volatility.

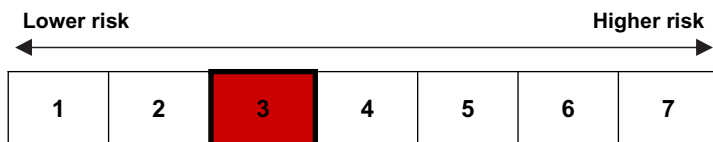
Other Information

What are the risks and what could I get in return?

Risk Indicator

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.



The risk indicator (SRI) assumes you keep the product for a minimum of 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

We have classified this product as 3 out of 7, which is a medium-low risk class.

This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the capacity of the Fund to pay you.

Be aware of currency risk. If you choose a foreign currency share class you will be exposed to currency risk and your final return will depend on the exchange rate between the foreign currency and your local currency. Currency hedged share classes aim to deliver a return that is as close as possible to the base currency performance of a fund, by reducing the effect of exchange rate movements between the base currency and the hedged currency. However, these techniques may not be fully effective in completely removing the exchange rate risk.

Performance Scenarios

What happens if Bridge Fund Management Ltd is unable to pay out?

What are the costs?

Cost over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. We have assumed that in the first year you would get back the amount that you invested (0 % annual return), for the other holding period that the product performs as shown in the moderate scenario. and that your USD 10 000,00 has been invested.
