What is this product?

This product is a fund of Nordea 1, SICAV, an investment company with variable share capital (SICAV) with multiple funds and governed by the Luxembourg Law of December 17, 2010 on Undertakings for Collective Investment.

Term

The fund is established for an unlimited duration.

The Board of Directors may compulsorily redeem or merge all the shares of the fund or share class. Circumstances under which such decision would occur are available in the fund's prospectus and accessible via www.nordea.lu. "Legal" section.

Objectives

Investment Objective The fund's objective is to provide shareholders with investment growth in the medium to long term.

Investment Strategy In actively managing the fund's portfolio, the management team selects securities that appear to offer superior investment opportunities.

Investment Policy The fund mainly invests in European government bonds. Specifically, the fund invests at least two thirds of total assets in debt securities issued or guaranteed by supranationals, sovereigns, sub-sovereigns, government owned or government guaranteed agencies in Europe or that are issued in European currencies. The fund may invest in, or be exposed to up to 10% of its total assets in debt securities rated BB+/Ba1 or lower, including unrated securities. The fund's major part of currency exposure is hedged to the base currency, although it may also be exposed (through investments or cash) to other currencies.

Derivatives: The fund may use derivatives for hedging (reducing risks), efficient portfolio management and to seek investment gains.



What are the risks and what could I get in return?

Risk Indicator





The risk indicator assumes you keep the product for 3 years. The actual risk can vary significantly if you cash in at an early stage and you might get back less.

The fund is intended for investors who accept and understand that the value of the fund is directly linked to the value of underlying investments, will fluctuate over time and that the invested amount can be lost entirely. How long should I hold it and can I take money out early?

Recommended holding period: 3 years

This product has no required minimum holding period but is designed for long-term investment; you should be prepared to stay invested for at least 3 years. Redemption requests received by the Transfer Agent before 15h30 CET on any valuation day will be processed that day. The share price will be the net asset value calculated for the day on which the transaction request is processed. Redemption requests received after the cut-

off will be processed on the next applicable valuation day.
