#### OBJECTIVES AND INVESTMENT POLICY

This Fund is classified as follows: Euro Zone equities

The Fund's investment objective is to seek long-term capital growth by outperforming its benchmark, the MSCI EMU SMID CAP (Net Return), over a minimum investment period of five years, while also taking ESG criteria into consideration. The Fund is a stock-picking fund and is managed on an active and discretionary basis with reference to its benchmark.

The Fund's investment universe is made up of the stocks that make up the MSCI EMU SMID CAP as well as other stocks of companies whose registered office is located in the Euro Zone and whose capitalisation is between EUR 500 million and EUR 10 billion (at the time they are first added to the portfolio). On an ancillary basis, the Fund may also invest in securities of companies located in the same geographical area with a market capitalisation of less than EUR 500 million (at the time they are first added to the portfolio). The Fund's composition may deviate significantly from that of the benchmark index.

The management team focuses on companies that enjoy a real competitive edge, operating on markets with strong entry barriers. The companies selected generate above-average profitability, which should enable them to finance their own long-term growth. These characteristics are identified during the analysis conducted by the fund managers, who choose them on a discretionary basis.

Initially, the management team takes into account extra-financial criteria in a significant way, thanks to a selectivity approach leading to the elimination of at least 20% of this universe.

There are strict sector exclusions on sectors such as tobacco, alcohol, gambling, activities relating to the extraction and production of energy from coal, oil and gas. Likewise, banks that have not committed to a policy that meets international standards for a fossil fuel phase-out will be excluded. The Fund cannot therefore invest in these sectors.

Our approach to adopting ESG criteria combines a "best-in-universe" and a "best-effort" approach, thereby favouring the development and improvement of best practices. Specific attention is paid to the analysis of human capital (human resources management and employee health and safety, etc.), corporate governance (preservation of minority shareholder's interests, remuneration policy, etc.) and controversies (industrial accidents, anti-competitive practices, etc.). The Management Company pledges that issuers representing at least 90% of the Fund's net assets have an ESG rating. Additional information on ESG analysis can be found in the "Investment Strategy" section of the prospectus.

Secondly, the investment process comprises four main steps: (i) filtering of the universe, (ii) analysis of fundamentals and company visits, (iii) valuation, and (iv) portfolio construction.

At least 75% of the Fund's assets is permanently invested in equities of issuers headquartered in a Euro Zone country. Investments in equities of issuers located outside the Euro Zone are limited to 10%.

The Fund may invest up to 25% in bonds and debt securities denominated in euro in order to generate income from cash. The instruments used shall primarily be transferable debt securities of short-term maturities, limited to issuers with a long-term AAA rating (Standard & Poor's or equivalent or according to the Management Company's internal rating). The Management Company does not use the ratings issued by ratings agencies automatically or in isolation, as it also applies its own internal analysis. In the event of a downgrade, the Management Company will take the interests of unitholders, market conditions and its own analysis of these fixed income products into account when respecting rating limits. The Fund may, without seeking overexposure, invest up to 100% of its net assets in all financial forwards or futures or options traded on regulated, organised or over-the-counter markets in France and other countries (hedging of and exposure to equity risk and hedging of currency risk) with a view to achieving the investment objective of the Fund through futures, options, currency swaps and currency forwards. The Fund will not use total return swaps.

The Fund may therefore hold up to 10% of its net assets in securities with embedded derivatives (convertible bonds, warrants).

The Fund may invest up to 10% of its net assets (i) in units or shares of UCITS under European Directive 2009/65/EC, (ii) in EU AIFs and/or in foreign investment funds mentioned in R.214-25 that meet the criteria of article R.214-13 of the French Monetary and Financial Code. These funds may be managed by ODDO BHF Asset Management SAS and ODDO BHF Asset Management GmbH, and will be compatible with the Fund's investment strategy.

The portfolio's maximum exposure to the various asset classes (equities, debt securities, UCIs and derivatives) is limited to 100% of net assets.

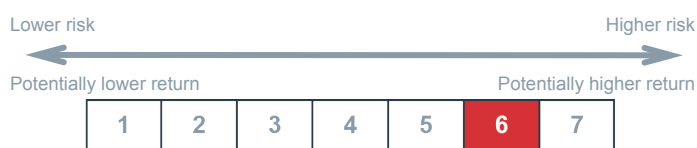
Subscription and redemption requests are centralised by the Depositary every Paris stock exchange trading day until 11:15 (Paris time, CET/CEST) and executed on the basis of the net asset value of the same day.

CN-EUR units accumulate their income.

Recommended investment horizon: 5 years

#### Why is the Fund placed in category 6?

The Fund presents a high level of risk due to its strategy of investing at least 75% of its assets in Euro Zone equities.

#### Material risks to the Fund that are not taken into account in the indicator:

**Liquidity risk:** the Fund invests in markets which may be affected by declines in liquidity. Low volumes of market transactions may have an impact on prices at which the manager opens or closes positions.

**Counterparty risk:** the risk of a counterparty's collapse, causing it to default on payment. The Fund may be exposed to this risk resulting from the use of forward financial instruments or temporary purchases and sales of securities contracts negotiated over-the-counter with a credit institution if the latter is unable to honour its commitments.

If one of these risks were to materialise, the Fund's net asset value may fall.

## CHARGES

Charges and fees paid are used to pay the costs of marketing and distributing units; these charges reduce the potential growth of the investment.

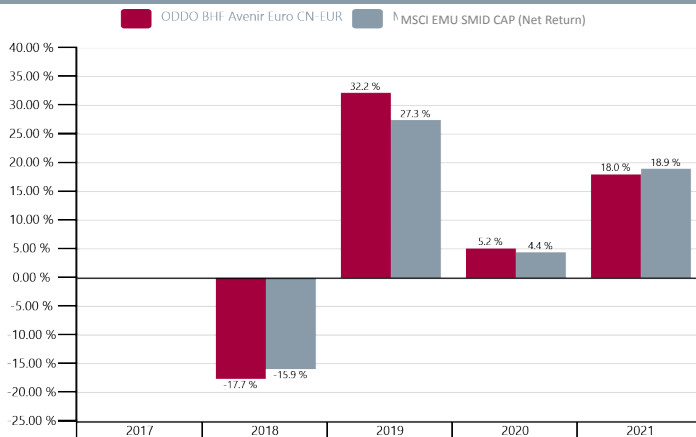
Ongoing charges are based on the expenses for the last financial year ended June 2021.
