What is this product?

TYPE OF PRODUCT

The product is a sub-fund of PA UCITS, an Undertaking for Collective Investment in Transferable Securities (UCITS) incorporated as a variable capital investment company (SICAV) under the laws of Luxembourg.

TERM

The Sub-Fund is established for an unlimited duration. However, the board of directors may propose to dissolve a sub-fund at a General Meeting of that sub-fund.

OBJECTIVES

Objectives and investment policy

The objective of the Sub-Fund is to achieve long-term capital appreciation by capitalising on the structural changes at work in the agri-food industry through investments along the entire agri-food value chain.

In order to achieve its objective, the Sub-Fund will invest at least 80% of its net assets in equities and equity-related securities offering an exposure to the agri-food value chain, from the production of the raw materials through their transfer in time and space, their potential transformation, to their consumption by the end consumers.

The sub-themes of the agri-food value chain will include (without being limited to):

- Robotics and automation within the agriculture industry (AgriTech);
- Nutrition and functional food;
- Alternative proteins and organic foods;
- Food safety and clean label;
- New forms of consumption; and
- Sustainable packaging solutions.

The Sub-Fund may also invest up to 20% of its net assets in the following eligible investments: convertible bonds (up to 10% of the Sub-Fund's net assets), shares or units of UCITS and other UCIs (up to 10% of the Sub-Fund's net assets), money market instruments and cash.

Except the sectoral focus, the choice of investments will neither be limited by geographical area (including emerging markets), nor in terms of currencies in which investments will be denominated.

The Sub-Fund will not make use of Securities Financing Transactions (SFTs) nor Total Return Swaps (TRS).

Derivatives For hedging and for any other purposes, the Sub-Fund may use all types of financial derivative instruments traded on a regulated market and/or over-the-counter.

Benchmark The Sub-Fund is actively managed. The Sub-Fund has no benchmark index and is not managed in reference to a benchmark index.

ESG information The Investment Manager integrates sustainability risks and opportunities into its research, analysis and investment decision-making processes. The Sub-Fund promotes certain environmental and social characteristics within the meaning of article 8 of SFDR but does not have a sustainable investment objective.

If one or more sustainability risks crystallise, there may be a negative impact on the value of the Sub-Fund, and therefore returns to investors and performance of the Sub-Fund. However, the Sub-Fund has a diligent approach in place to seek to mitigate the impact of sustainability risk on its returns, as described above.

Dividend Policy This Class is cumulative. Dividend distributions are not planned.

Share Class Currency The currency of the Class is CHF.

The recommended holding period of this product is determined to allow sufficient time for this product to reach its objectives and avoiding short term market fluctuations.

The return of the product is determined using the Net Asset Value (the "NAV") calculated by FundPartner Solutions (Europe) S.A. (the "Administrative Agent"). This return depends mainly on the market value fluctuations of the underlying investments.

INTENDED RETAIL INVESTORS

The product is suitable for retail investors with limited knowledge of the underlying financial instruments and no financial industry experience. The product is compatible with investors who may bear capital losses and who do not need capital guarantee. The product is compatible with clients looking for growing their capital and who wish to hold their investment over 3 years.

Asset segregation The assets and liabilities of each sub-fund are segregated by law, which means that the performance of the assets in other sub-funds does not influence the performance of your investment.

Dealing The NAV of the Sub-Fund shall be calculated on each Business Day (the "Calculation Day"), on the basis of the pricing of the preceding Business Day (the "Valuation Day"). If such Valuation Day is not a Business Day, the NAV of the Sub-Fund will be calculated the immediately following Business Day. For any subscription or redemption request received by the Fund, prior to 2 p.m. Luxembourg time, on the relevant Valuation Day, the NAV calculated on the Calculation Day will be applicable.

Switching Shareholders may apply for any share of any sub-fund to be converted into shares of another sub-fund, provided that the conditions for accessing the target class, type or sub-type, are fulfilled with respect to the Sub-Fund, on the basis of their respective NAV calculated on the Valuation Day following receipt of the conversion request. The redemption and subscription costs connected with the conversion may be charged to the shareholder as indicated in the prospectus. What are the risks and what could I get in return?

Risk indicator



The risk indicator assumes you keep the product for 3 years.

What happens if FundPartner Solutions (Europe) S.A. is unable to pay out?

The Management Company is not making any payment to you in relation to the Sub-Fund and you would still be paid in case of a default from the Management Company.

The Sub-Fund's assets are held with a separate company, the Depository, so the Sub-Fund's ability to pay out would not be affected by the insolvency of the Management Company. However, in the event of the Depository's insolvency, or its delegates, the Sub-Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depository is required by law and regulation to segregate its own assets from the assets of the Sub-Fund. The Depository will also be liable to the Sub-Fund or its investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfill its obligations (subject to certain limitations).

If the Sub-Fund is terminated or wound up, the assets will be liquidated and you will receive an appropriate share of any proceeds but you may lose part or all of your investment.

There is no compensation or guarantee scheme protecting you from a default of the Depository.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

If such Valuation Day is not a Business Day, the NAV of the Sub-Fund will be calculated the immediately following Business Day. For any subscription or redemption request received by the Fund, prior to 2 p.m. Luxembourg time, on the relevant Valuation Day, the NAV calculated on the Calculation Day will be applicable.
